(57) **CLAIM**

The ornamental design for a tourniquet handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tourniquet handle according to the present invention.

FIG. 2 is a plan view of the tourniquet handle according to the present invention.

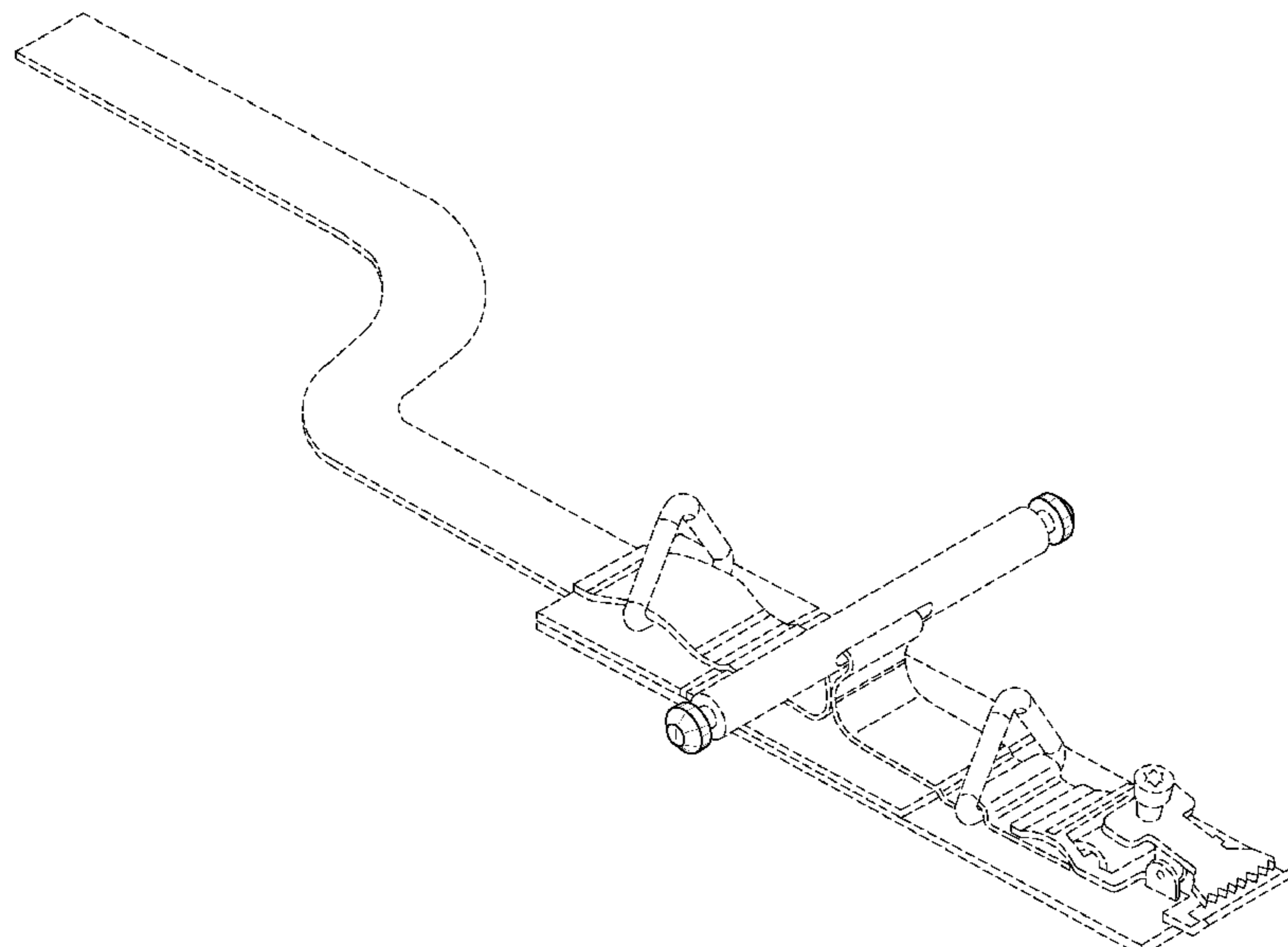
FIG. 3 is a plan view of the tourniquet handle according to the present invention rotated 1/4 turn from the view depicted in FIG. 2.

FIG. 4 is an end view of the tourniquet handle according to the present invention; and,

FIG. 5 is an end view of the tourniquet handle according to the present invention.

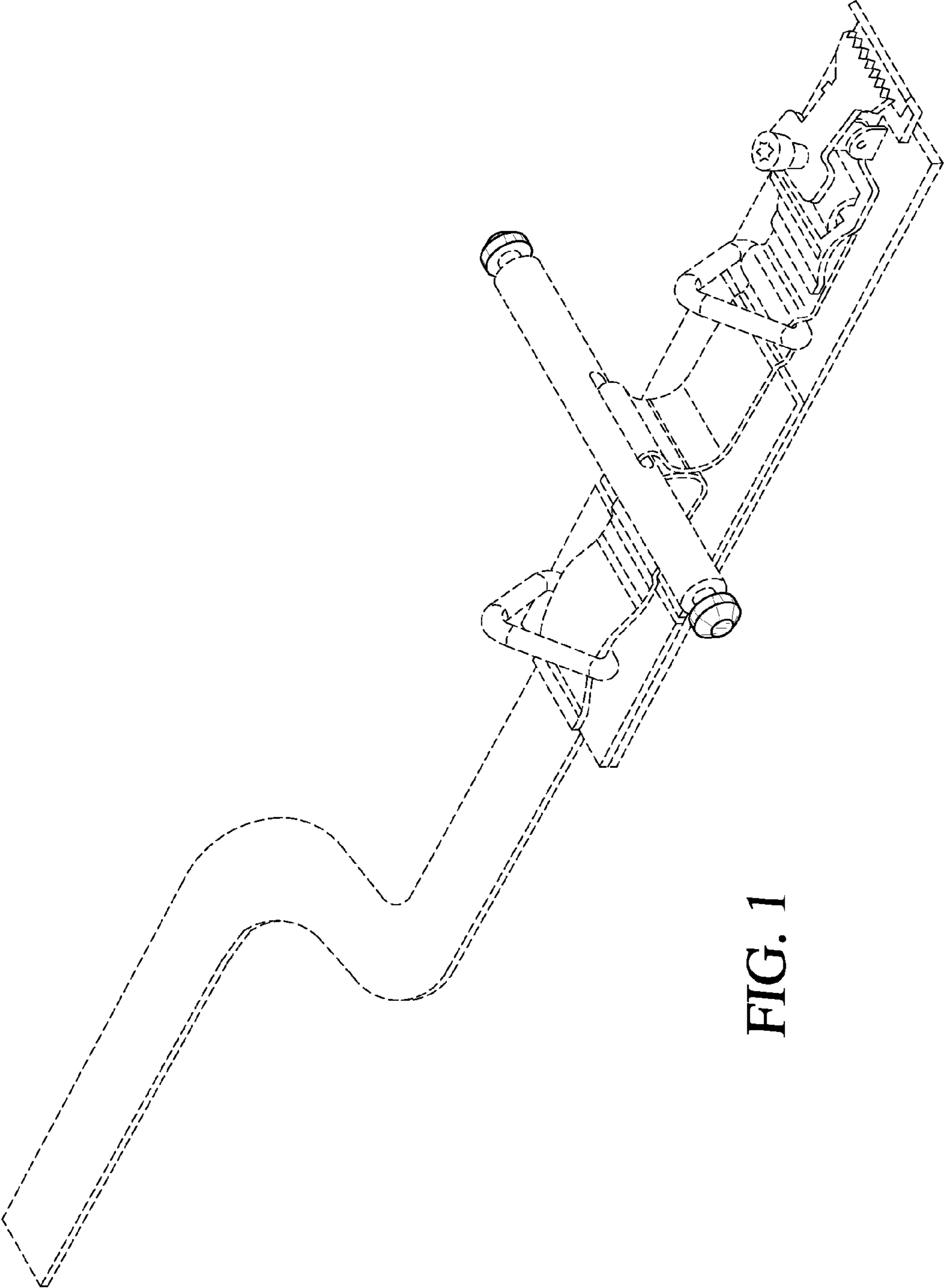

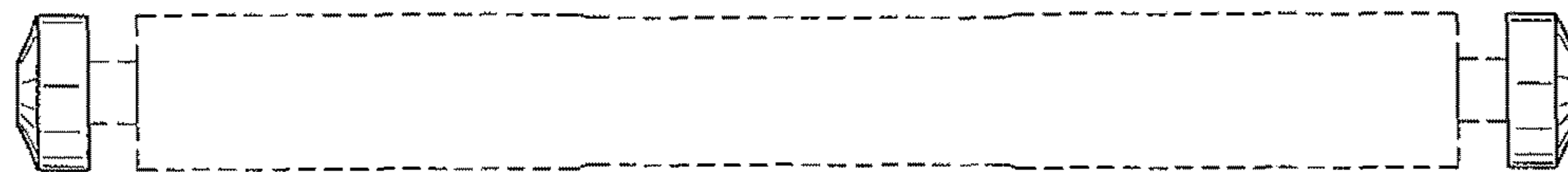

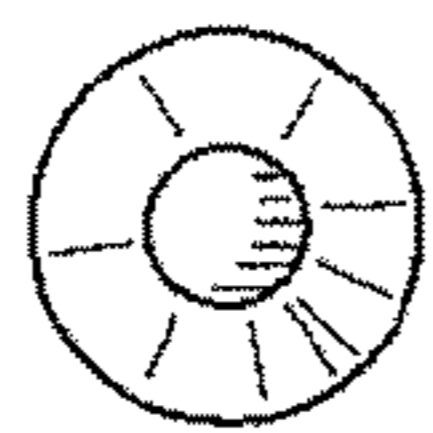

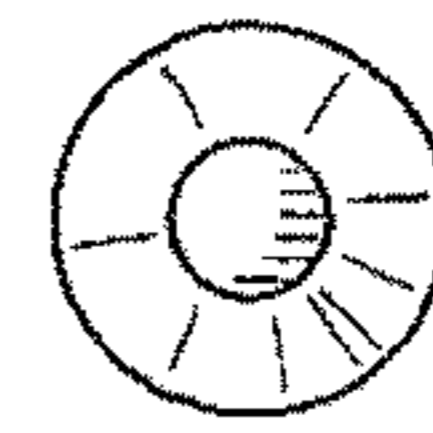
