**DESCRIPTION**

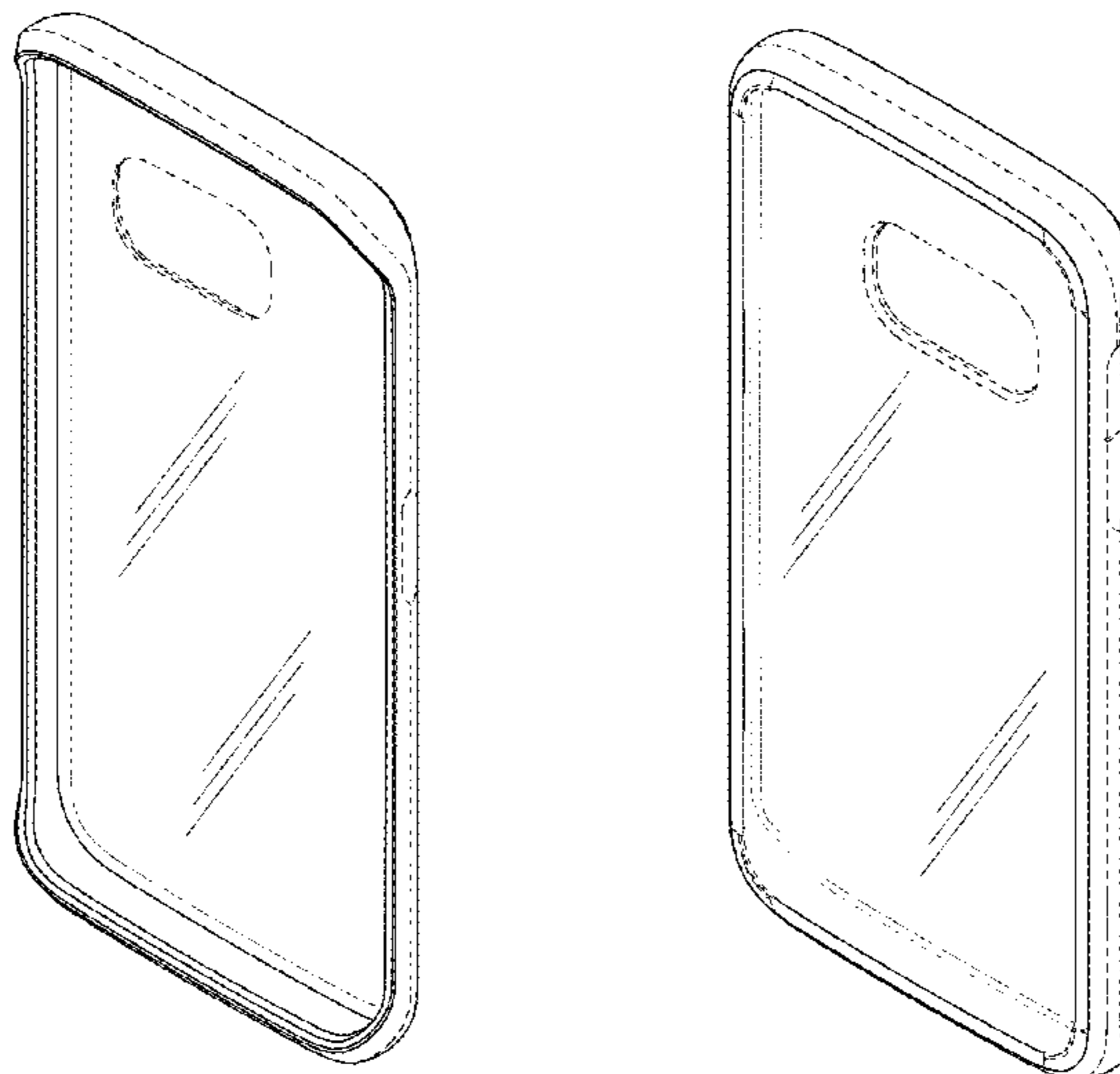

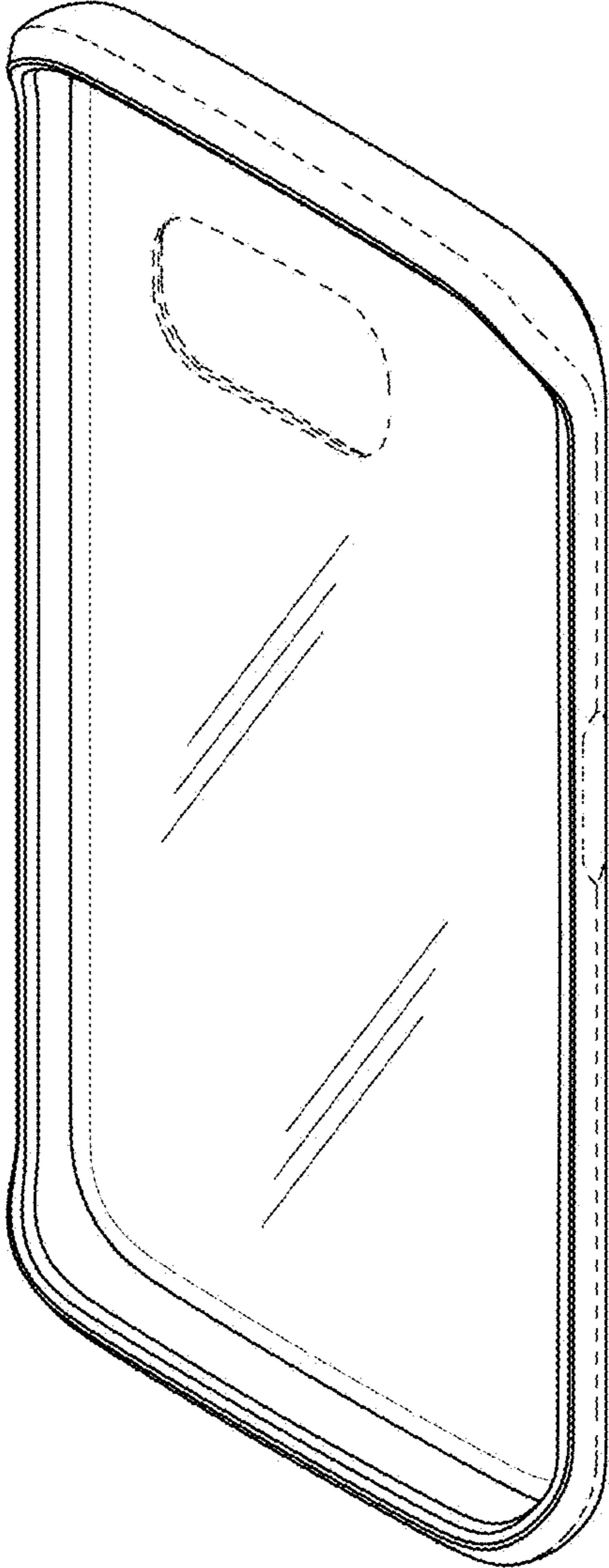

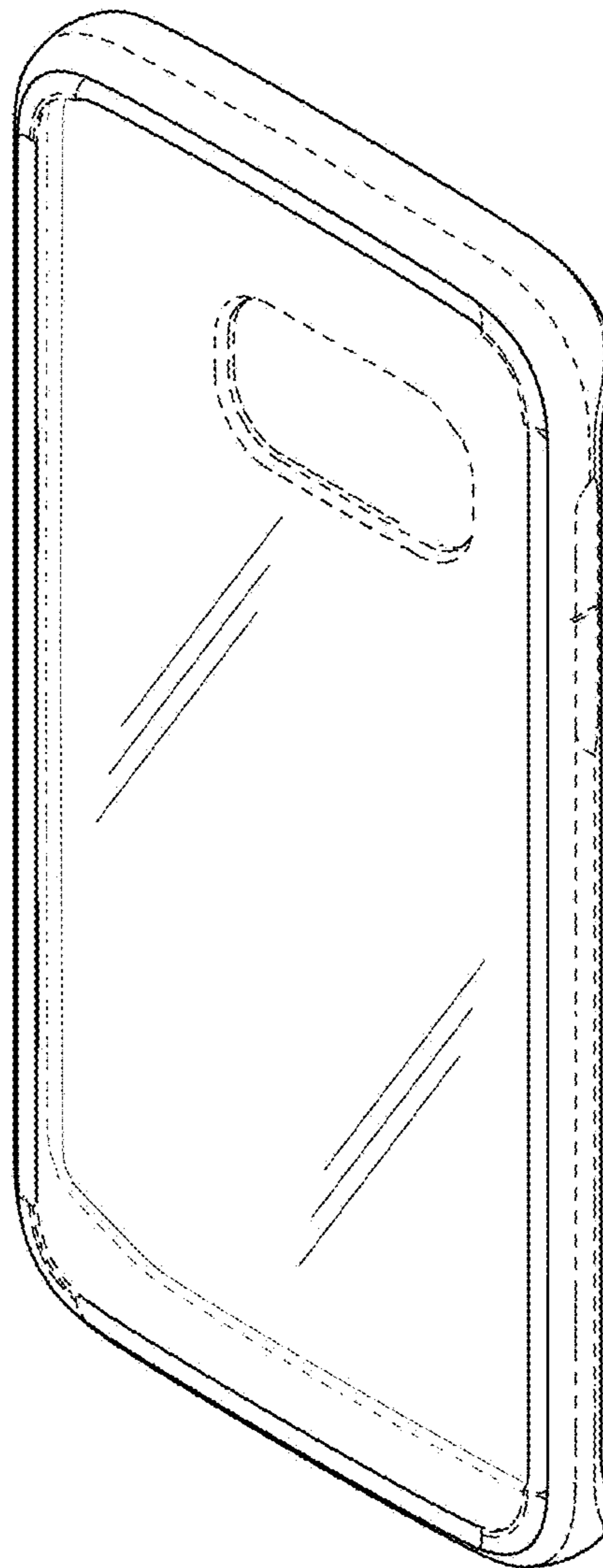

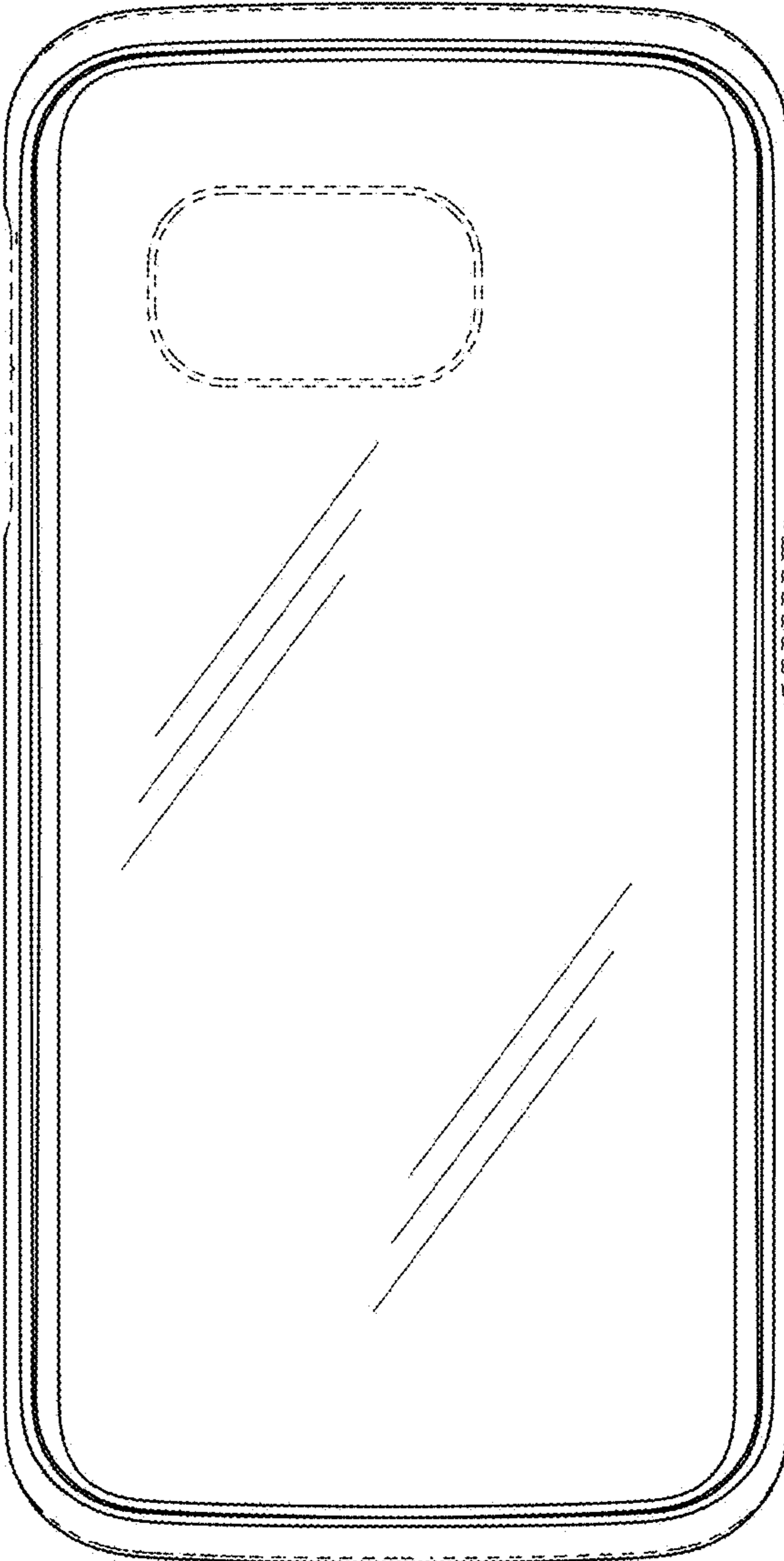

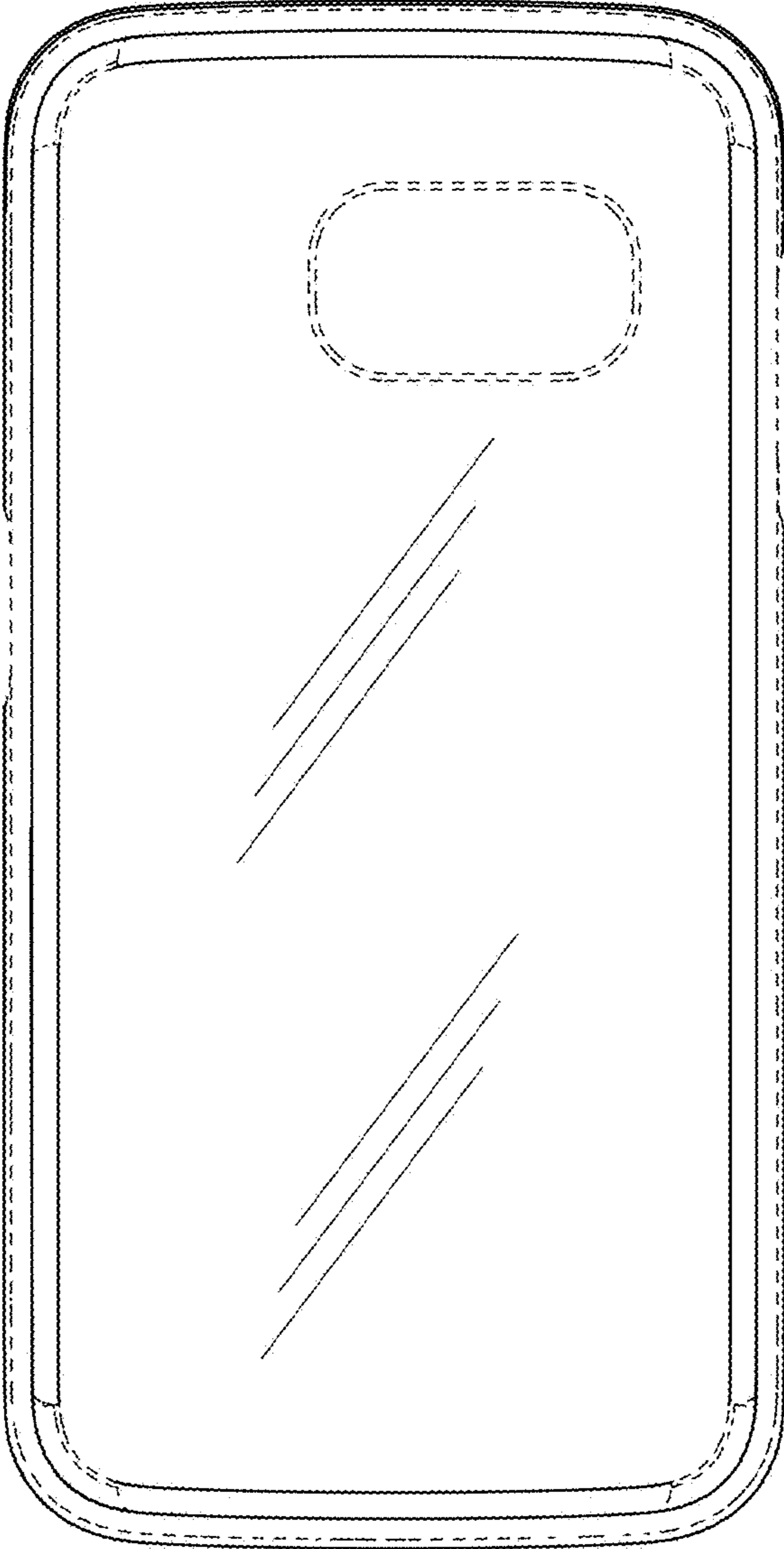

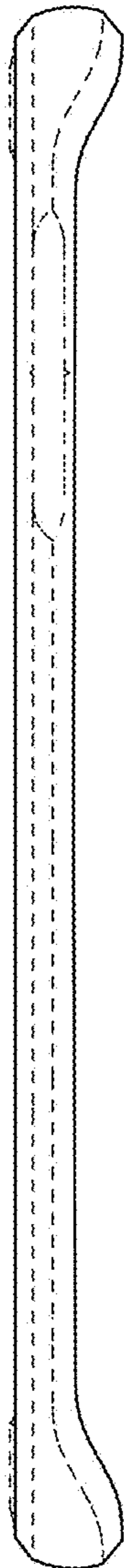

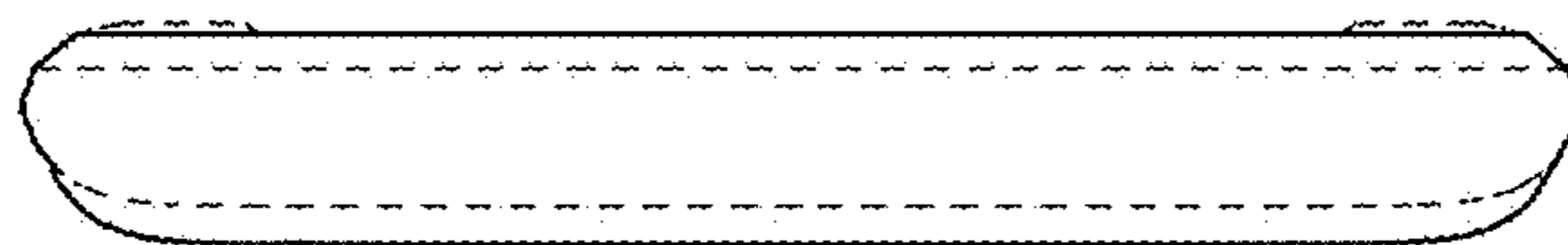
