[57] **CLAIM**

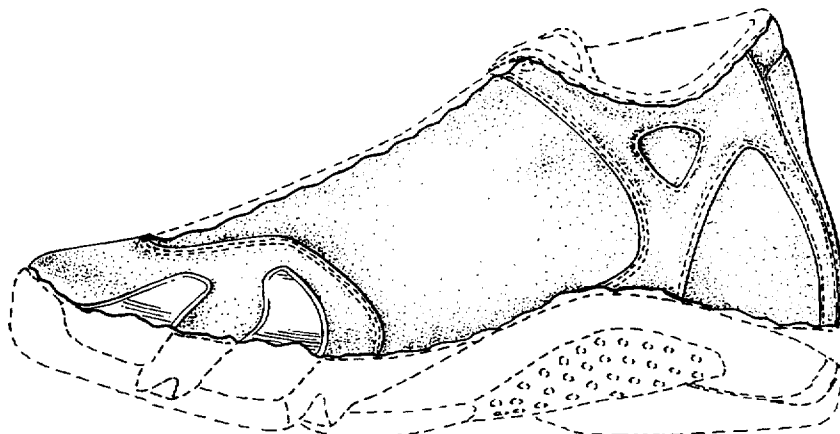
The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe upper showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a side elevational view of one side thereof;
 FIG. 5 is a side elevational view of the other side thereof; and,
 FIG. 6 is a top plan view thereof.

The broken line showing of a shoe sole and the remaining portion of the upper shown in FIGS. 1—6 is for illustrative purposes only and forms no part of the claimed design.

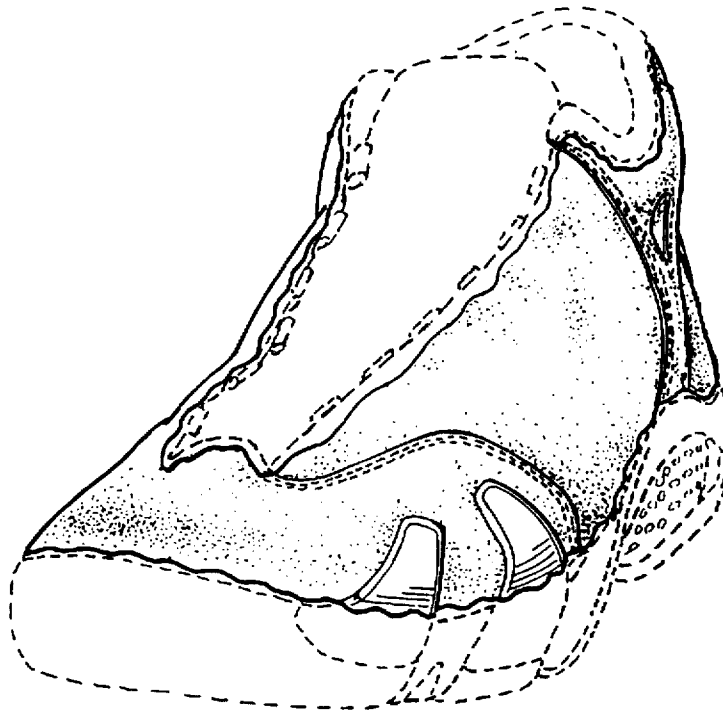

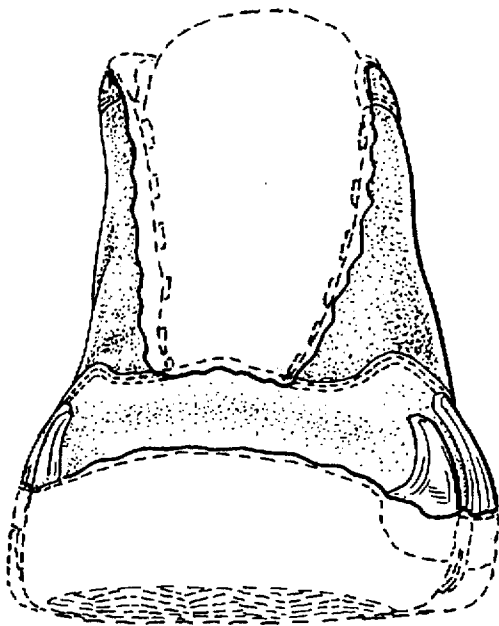

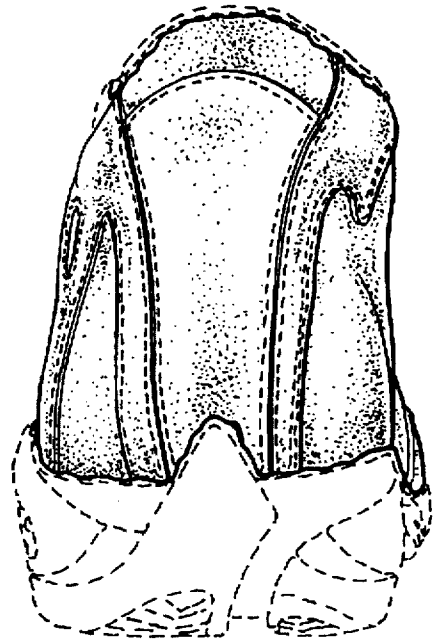

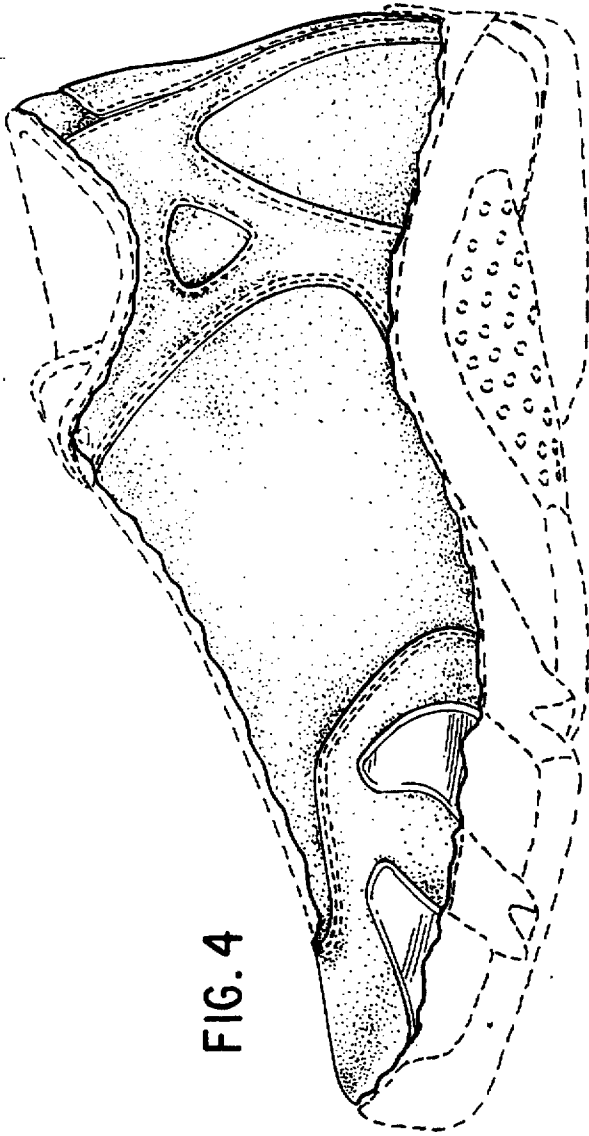

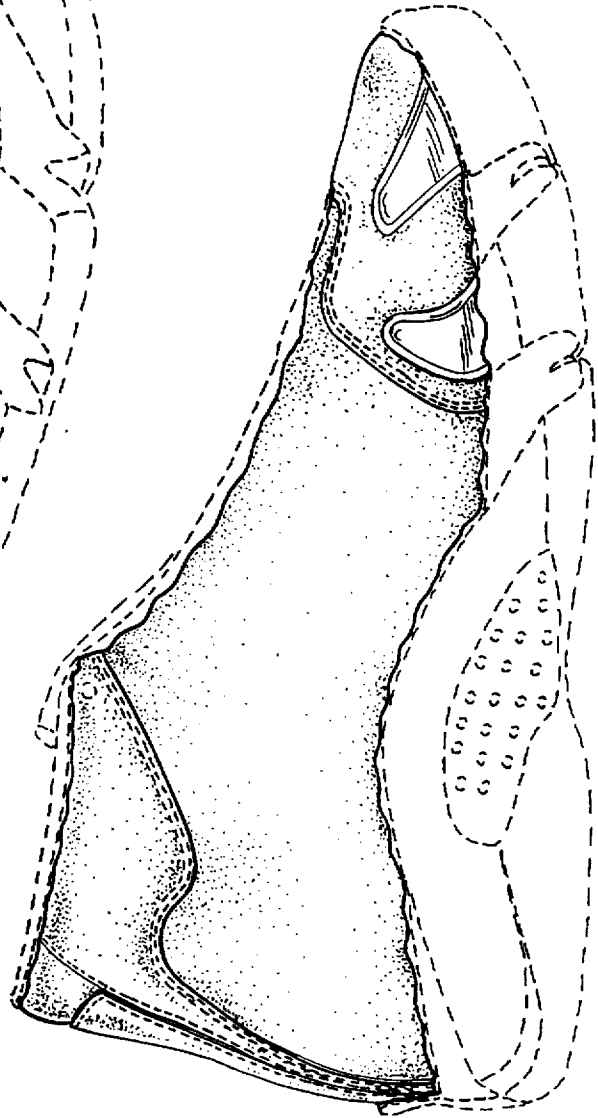

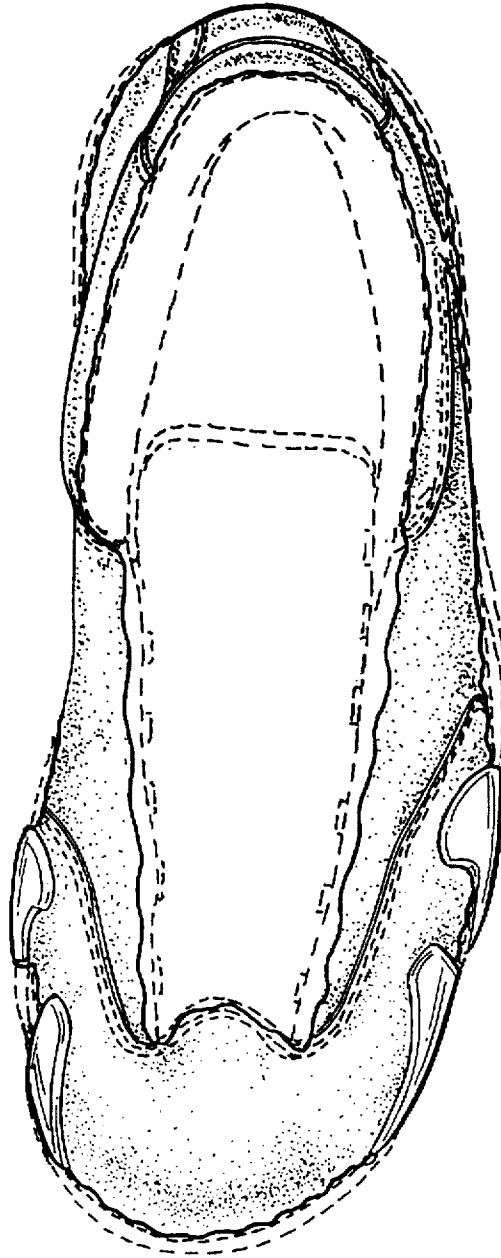
