FIG. 11 is a front elevational view of the embodiment of FIG. 8;

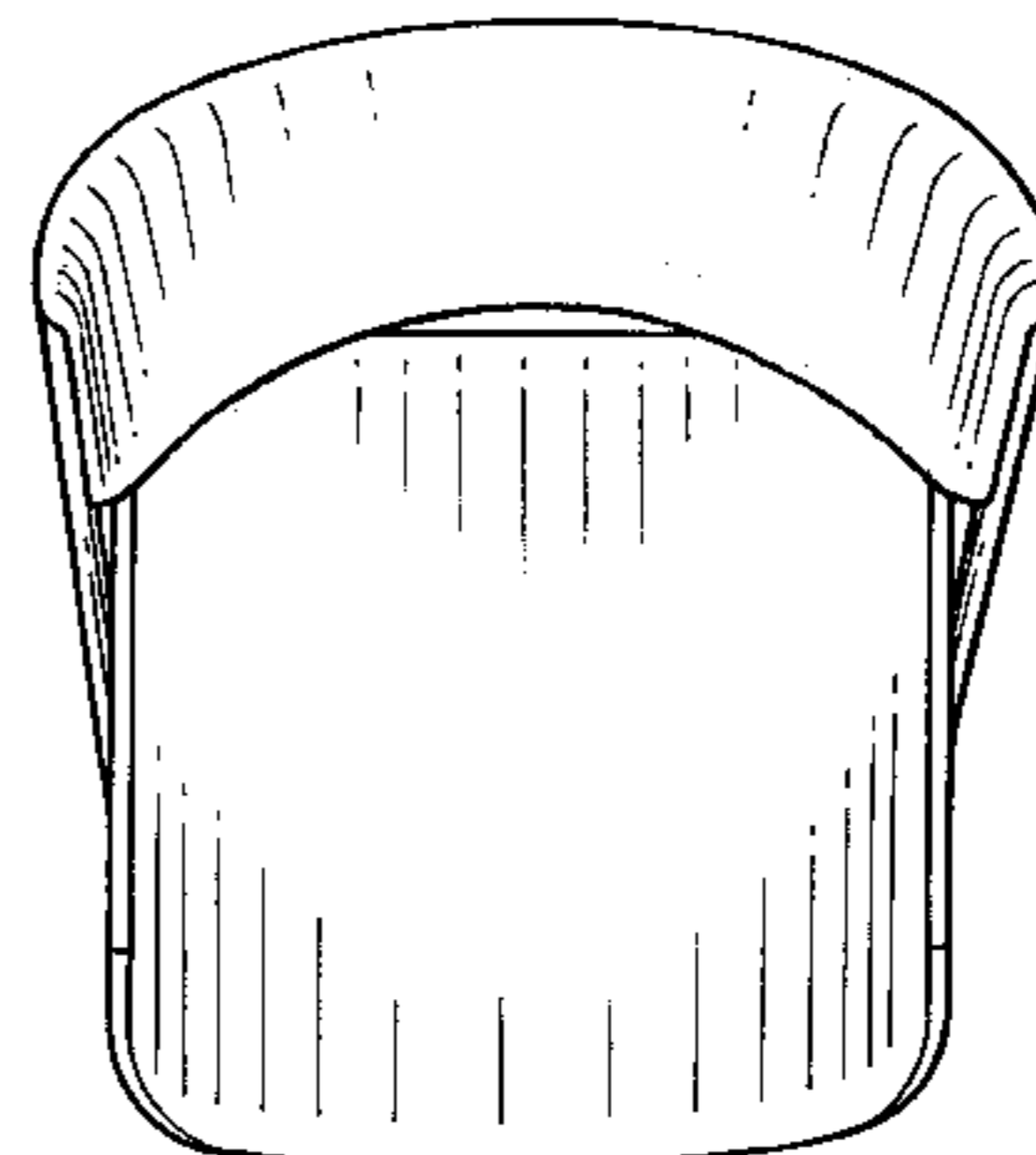
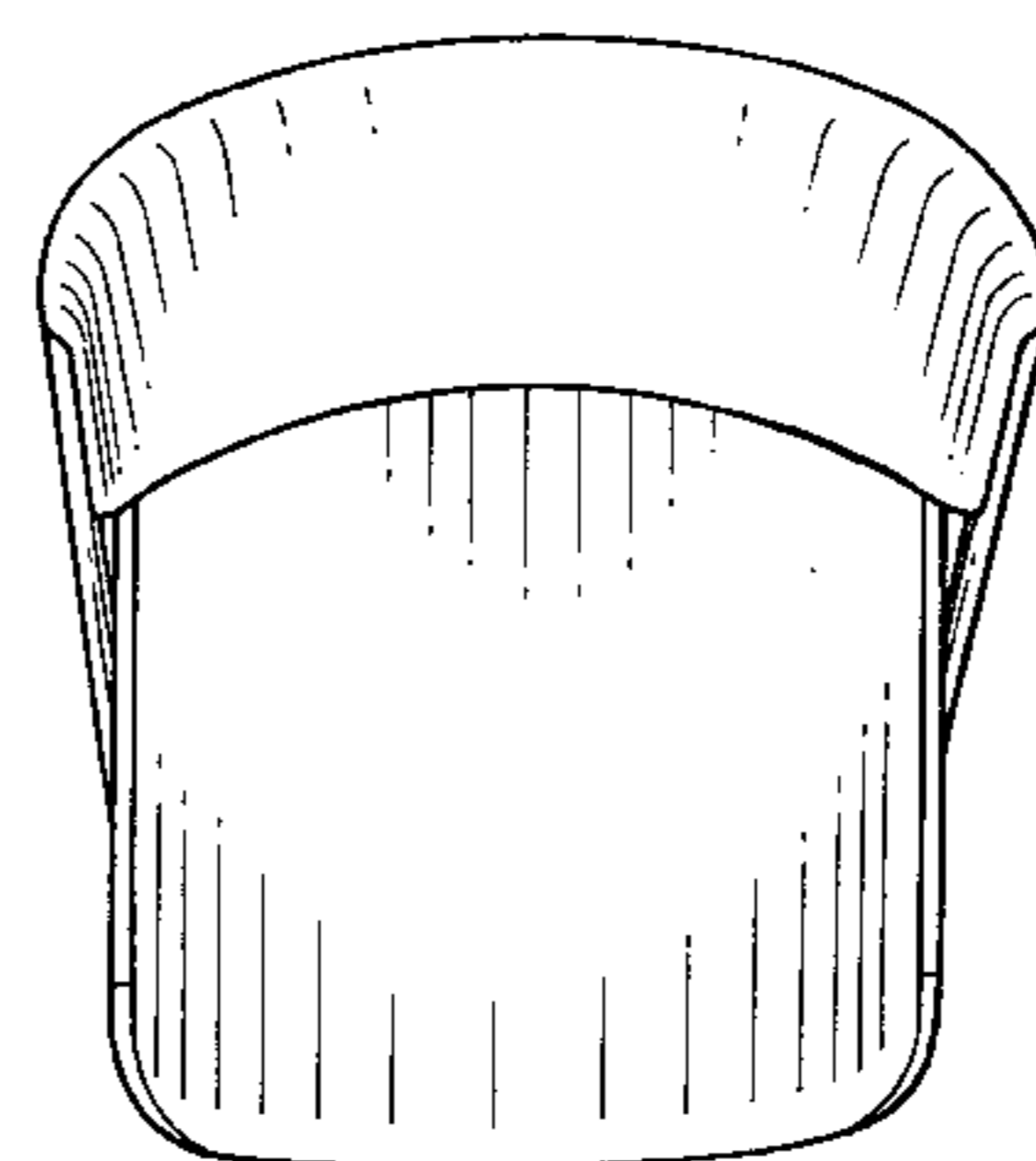
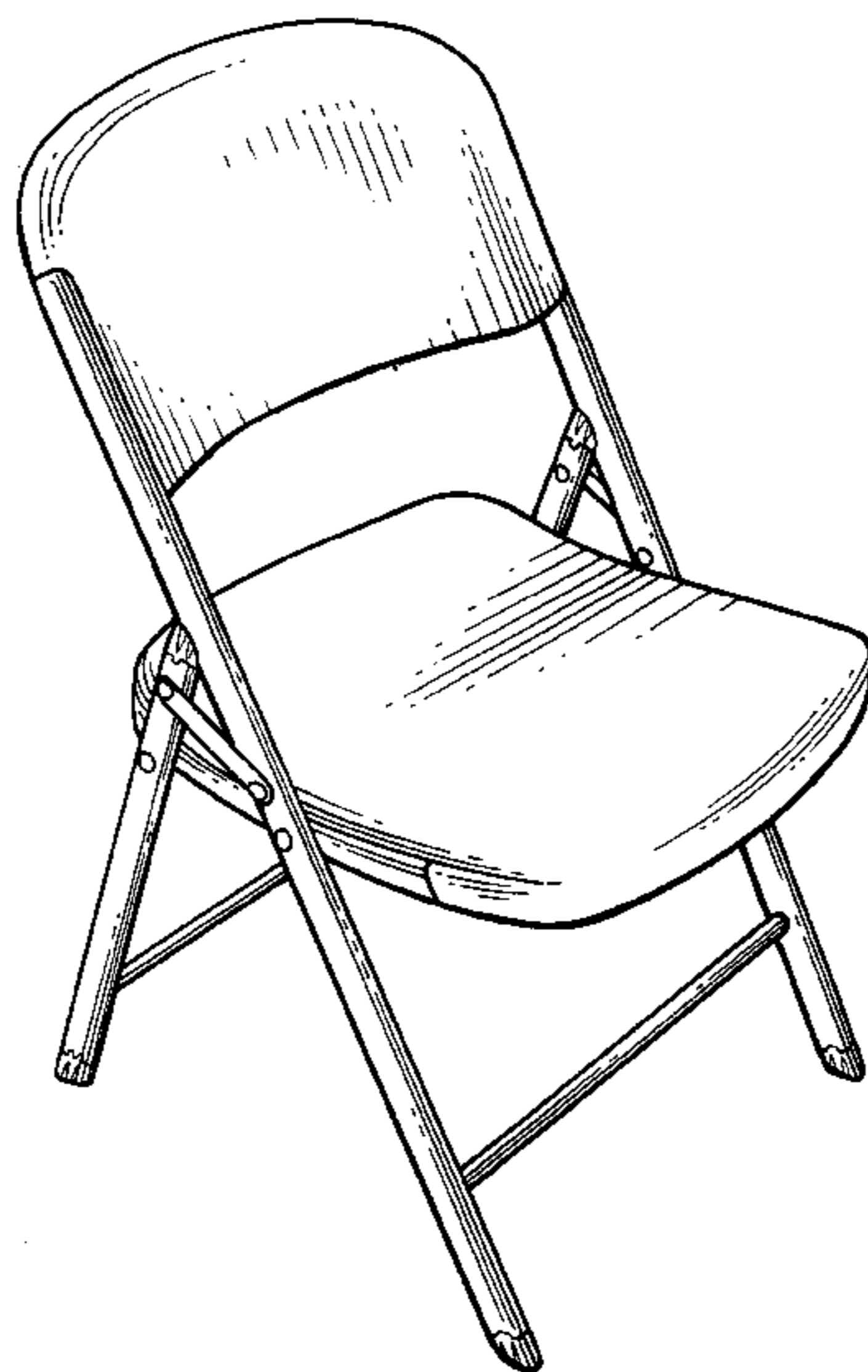
FIG. 12 is a rear elevational view of the embodiment of FIG. 8;

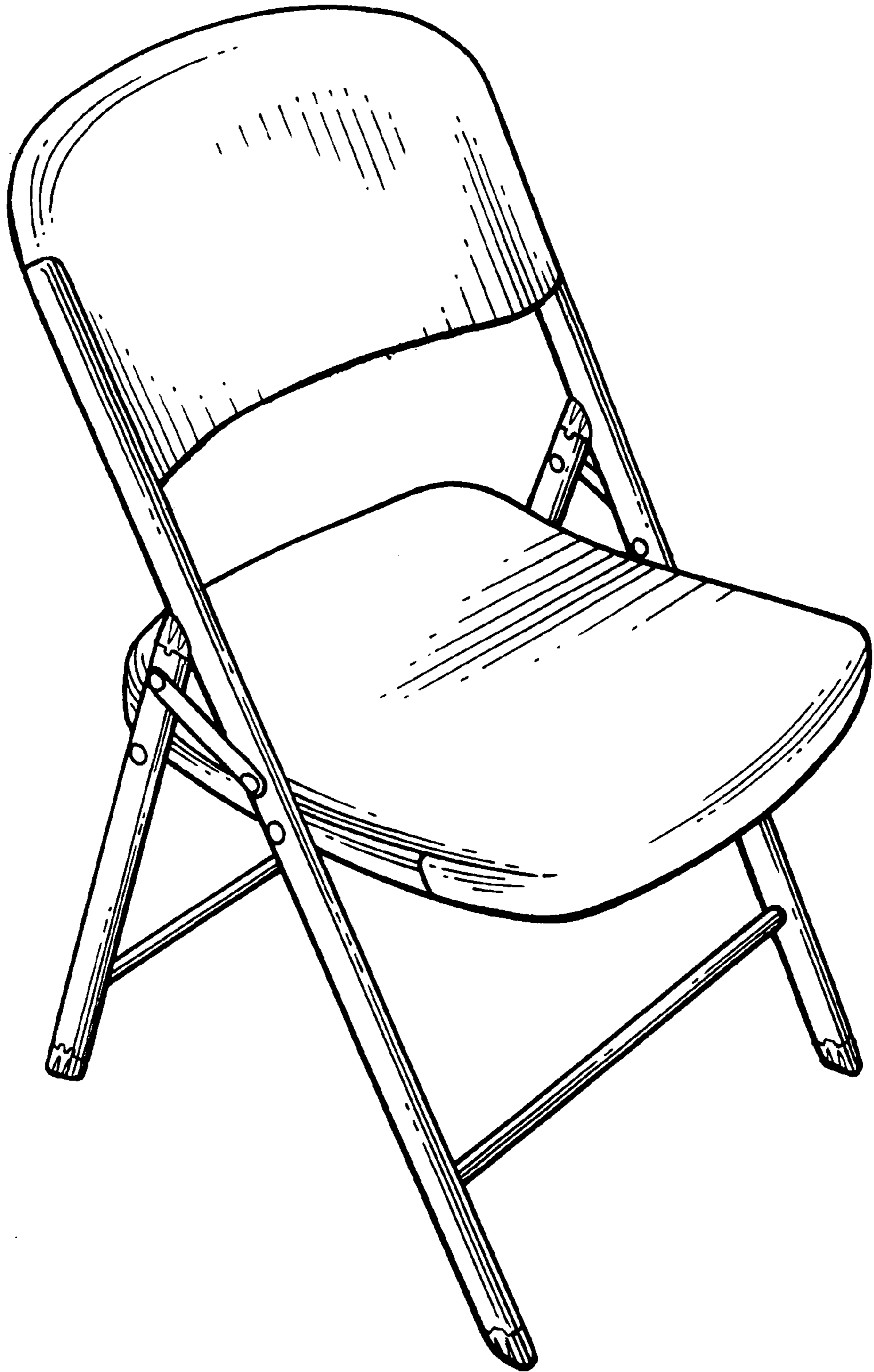

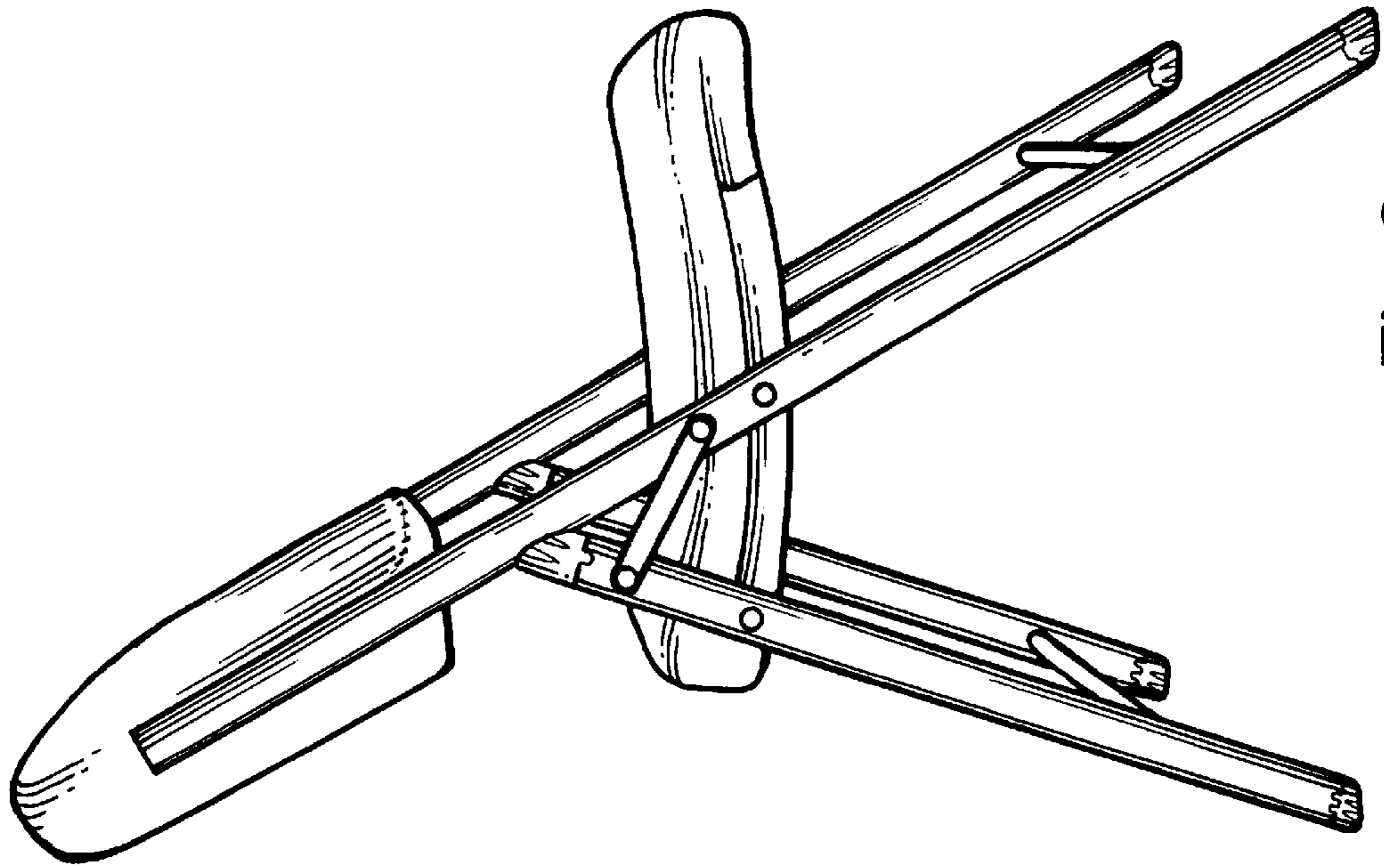

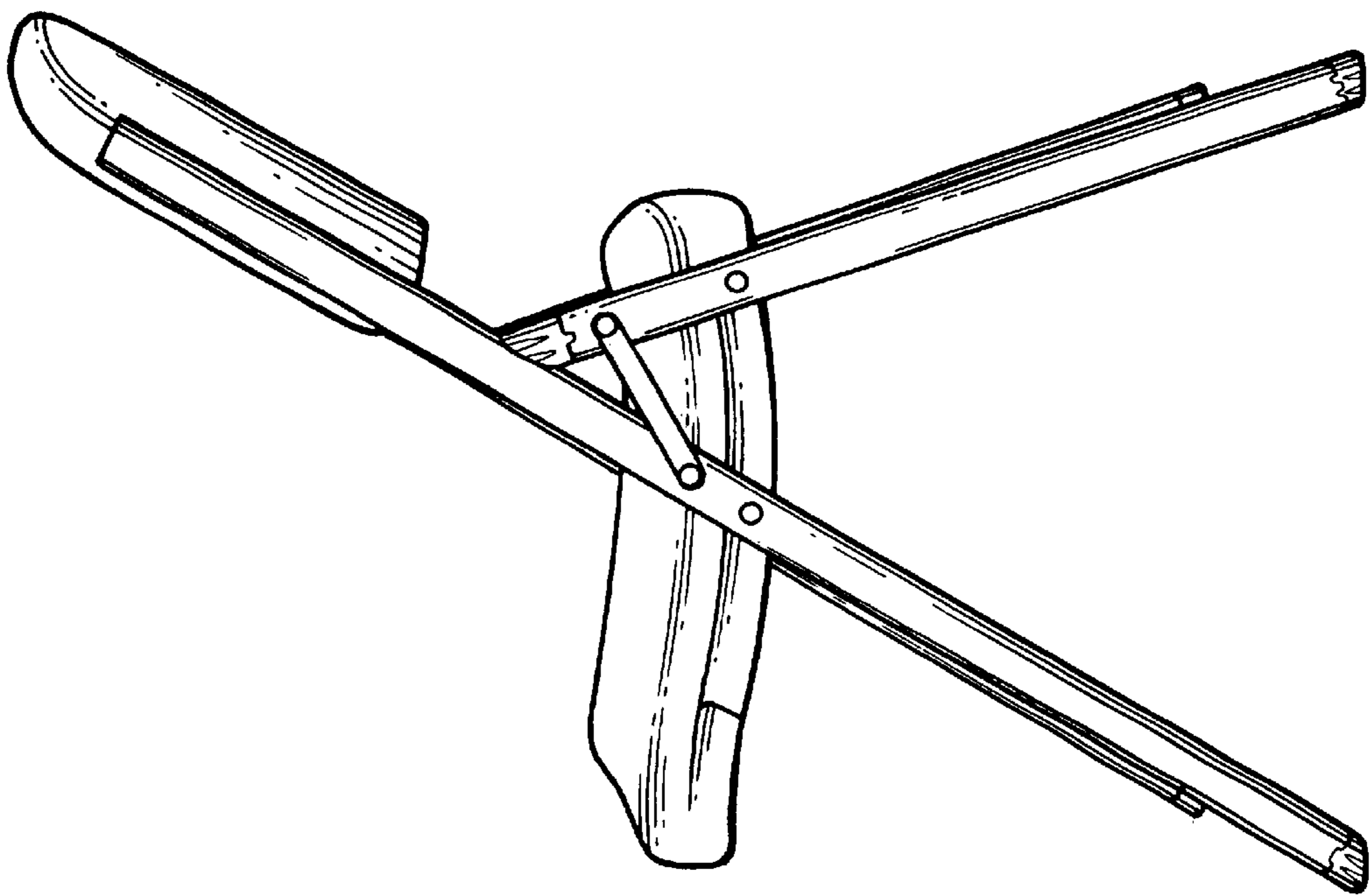

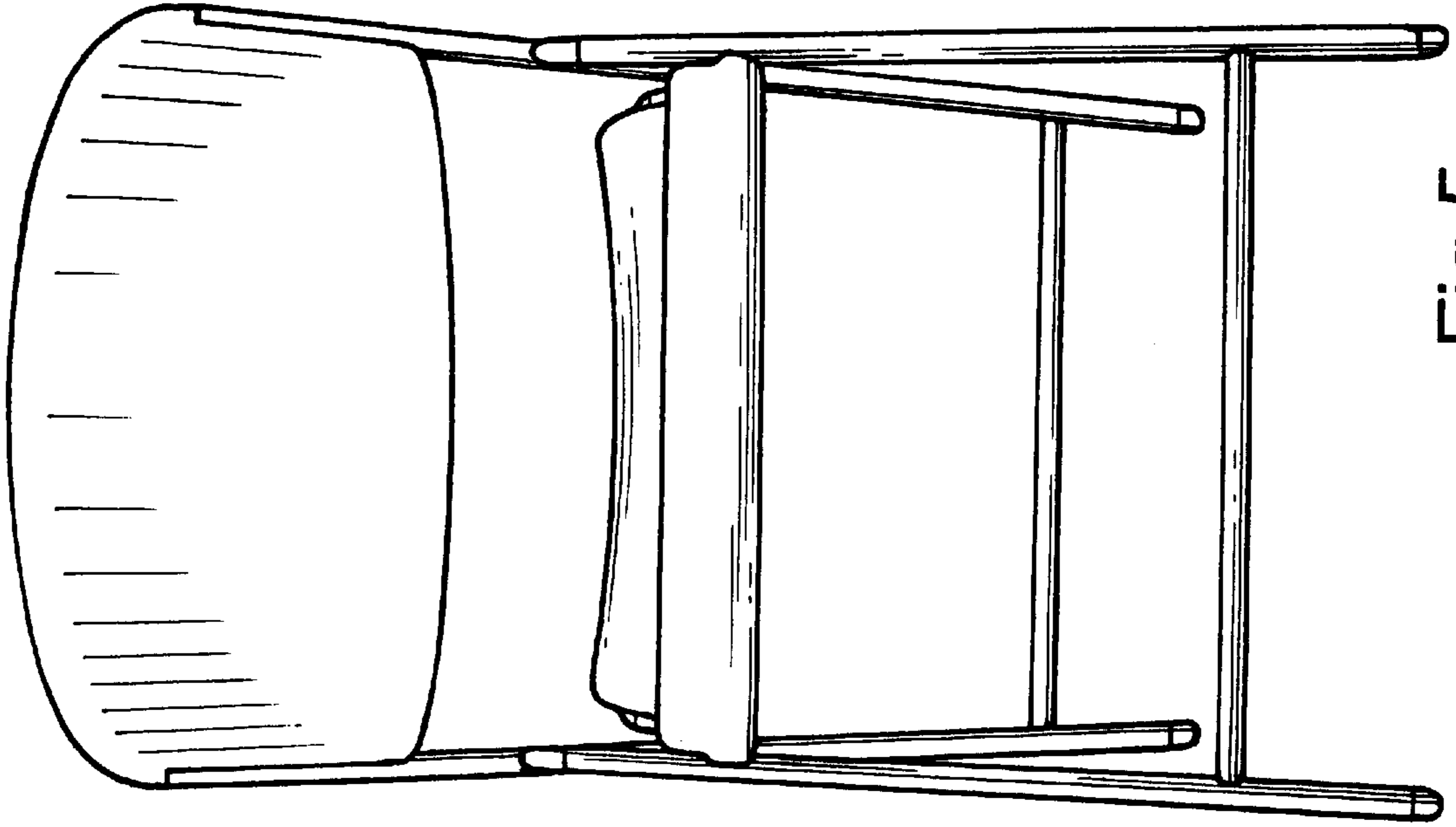

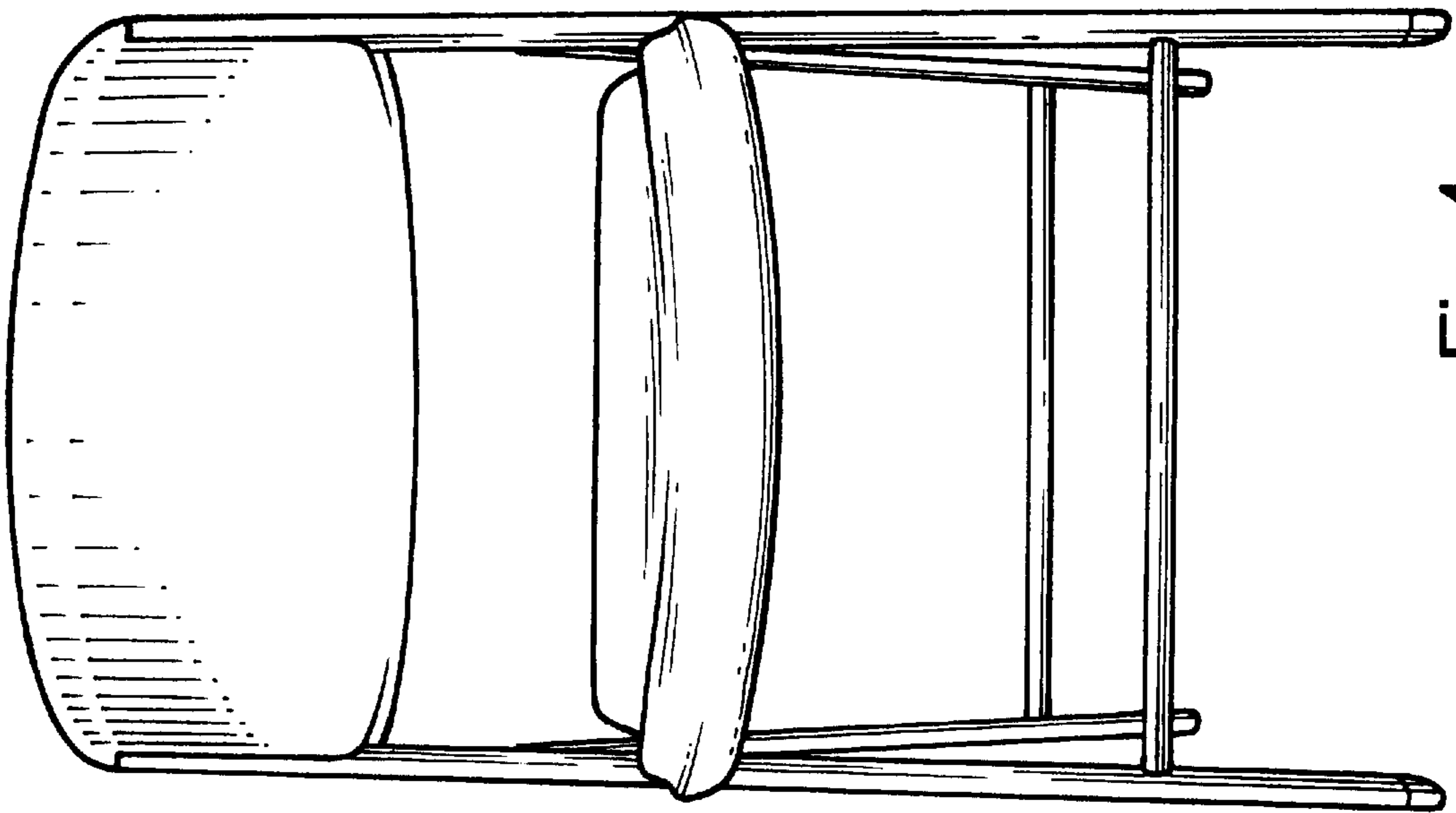

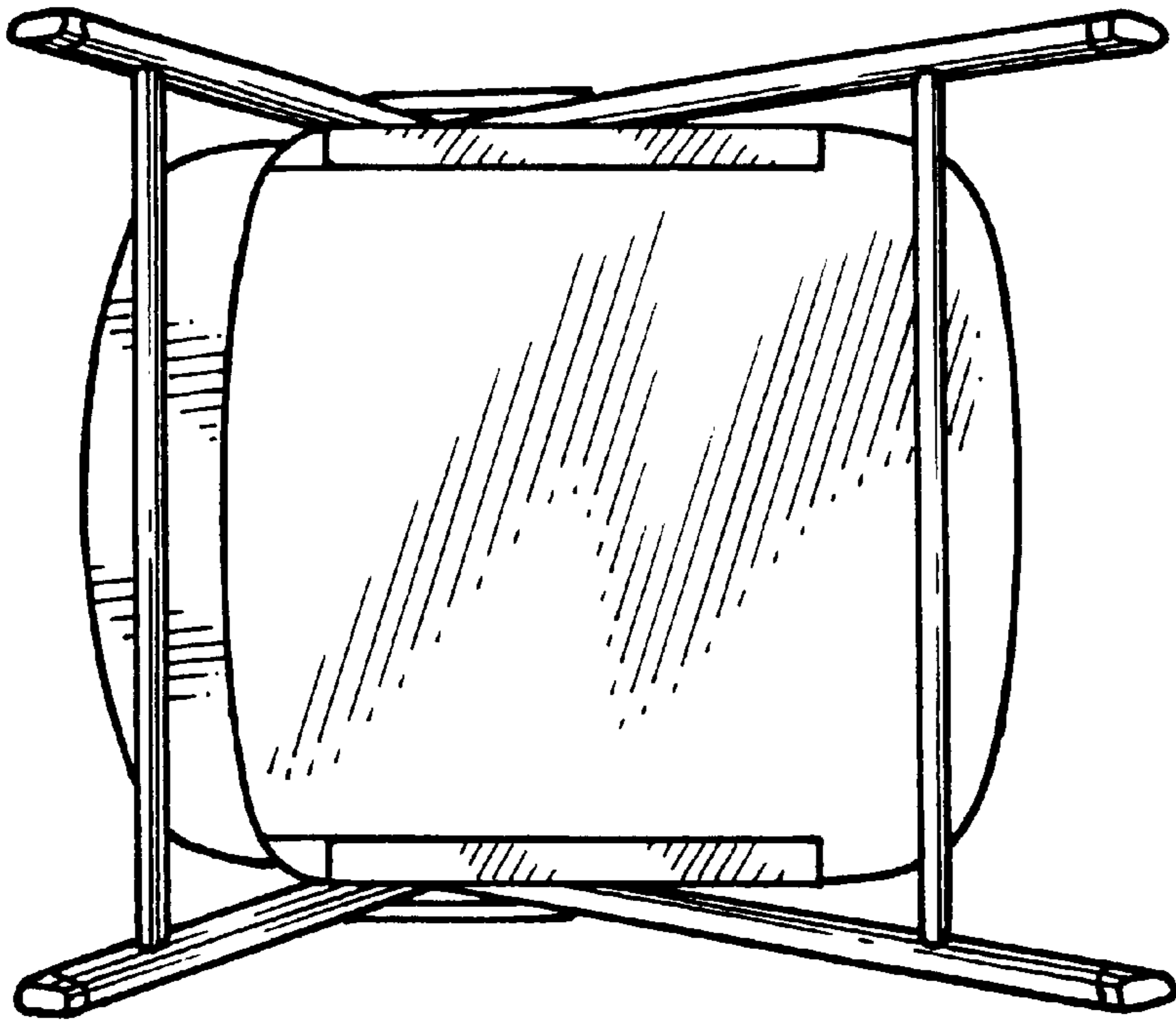

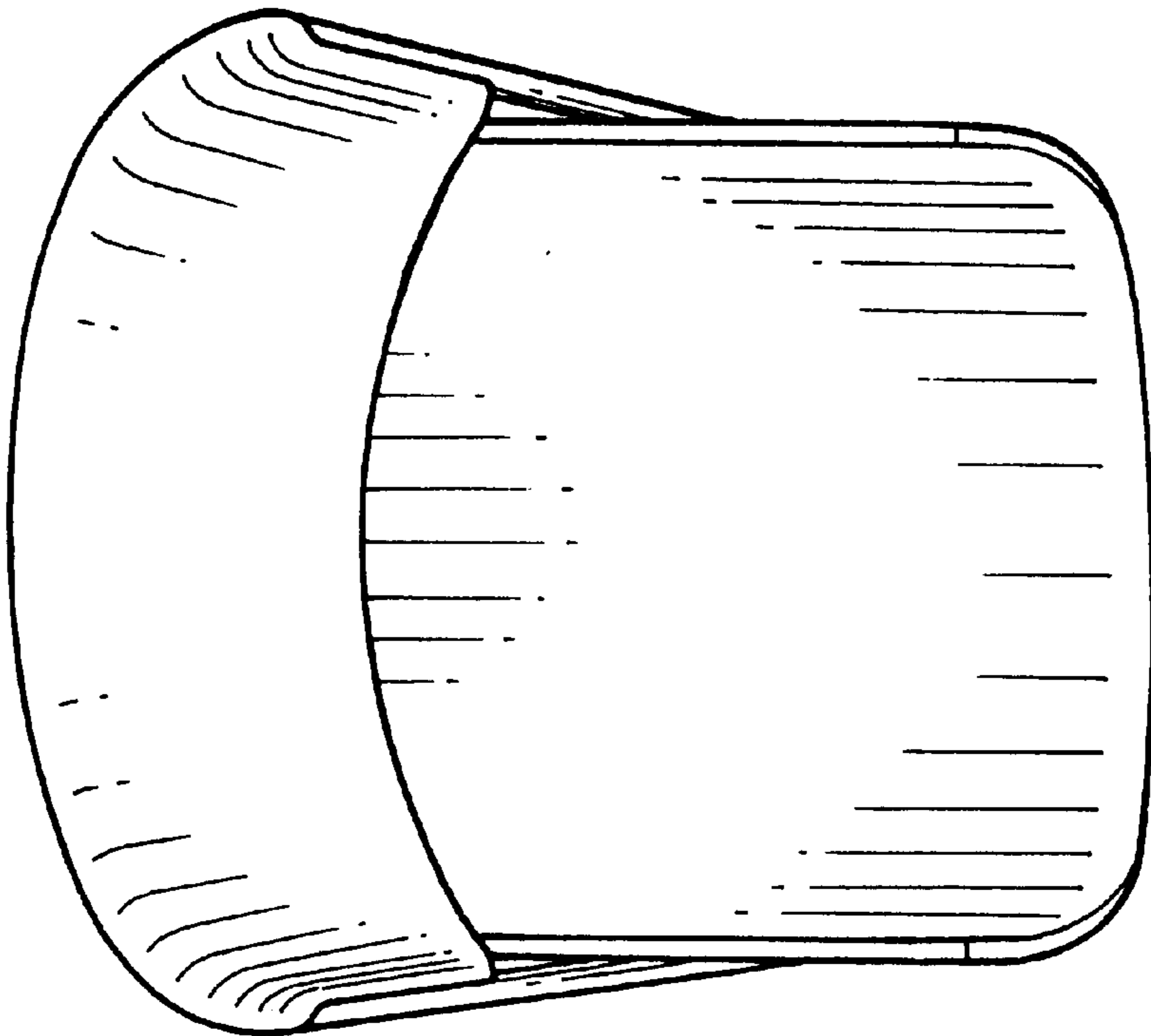

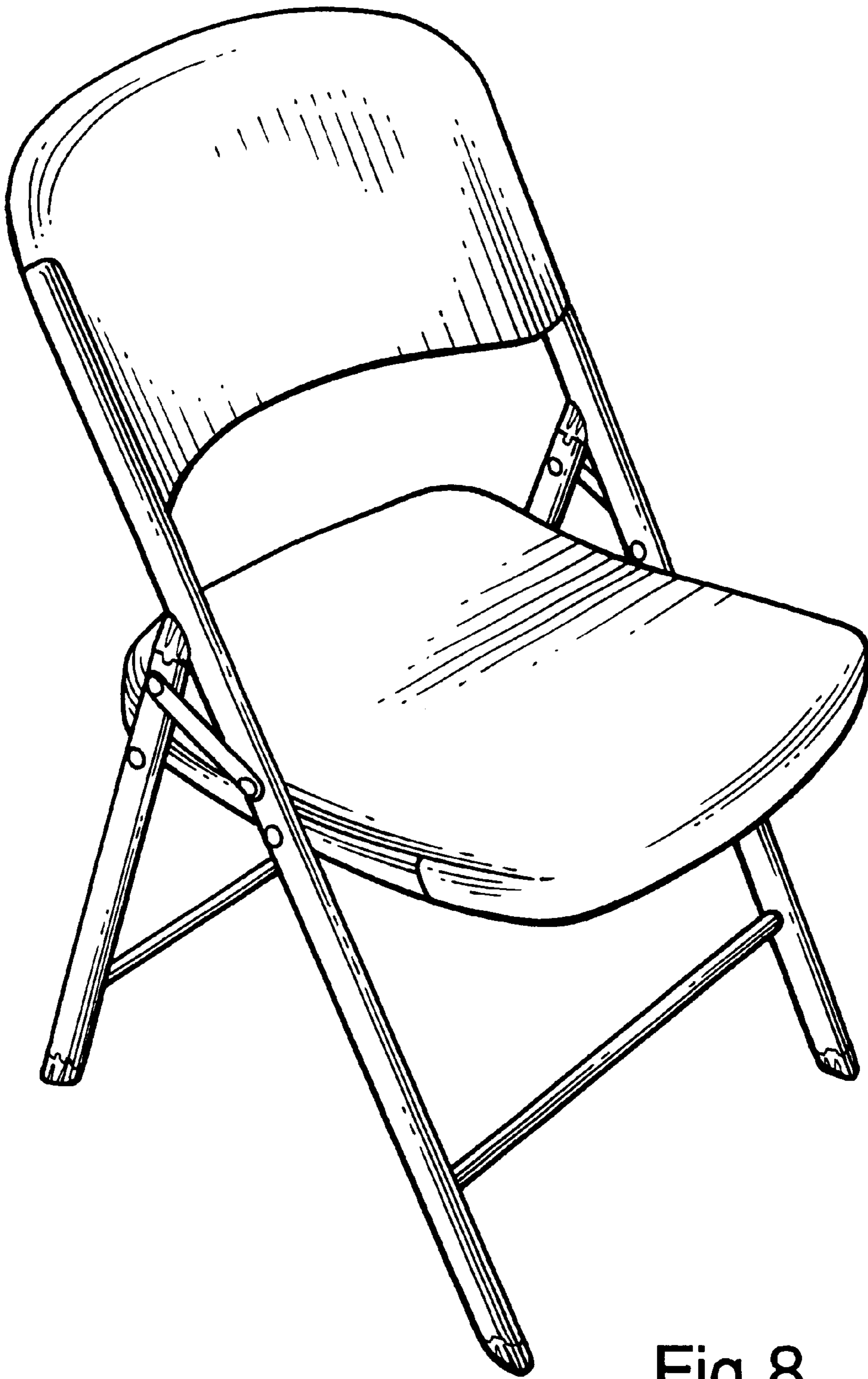

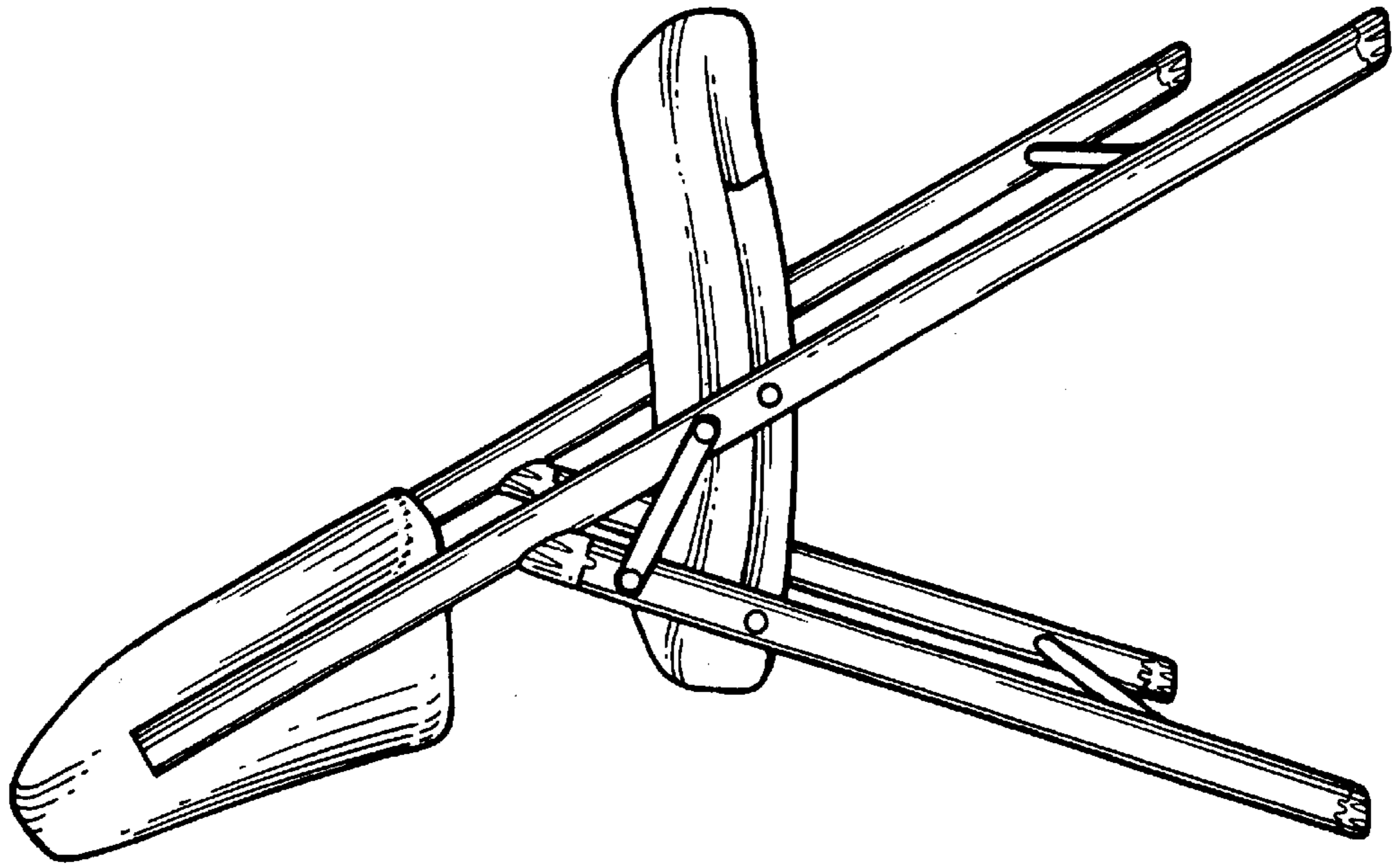

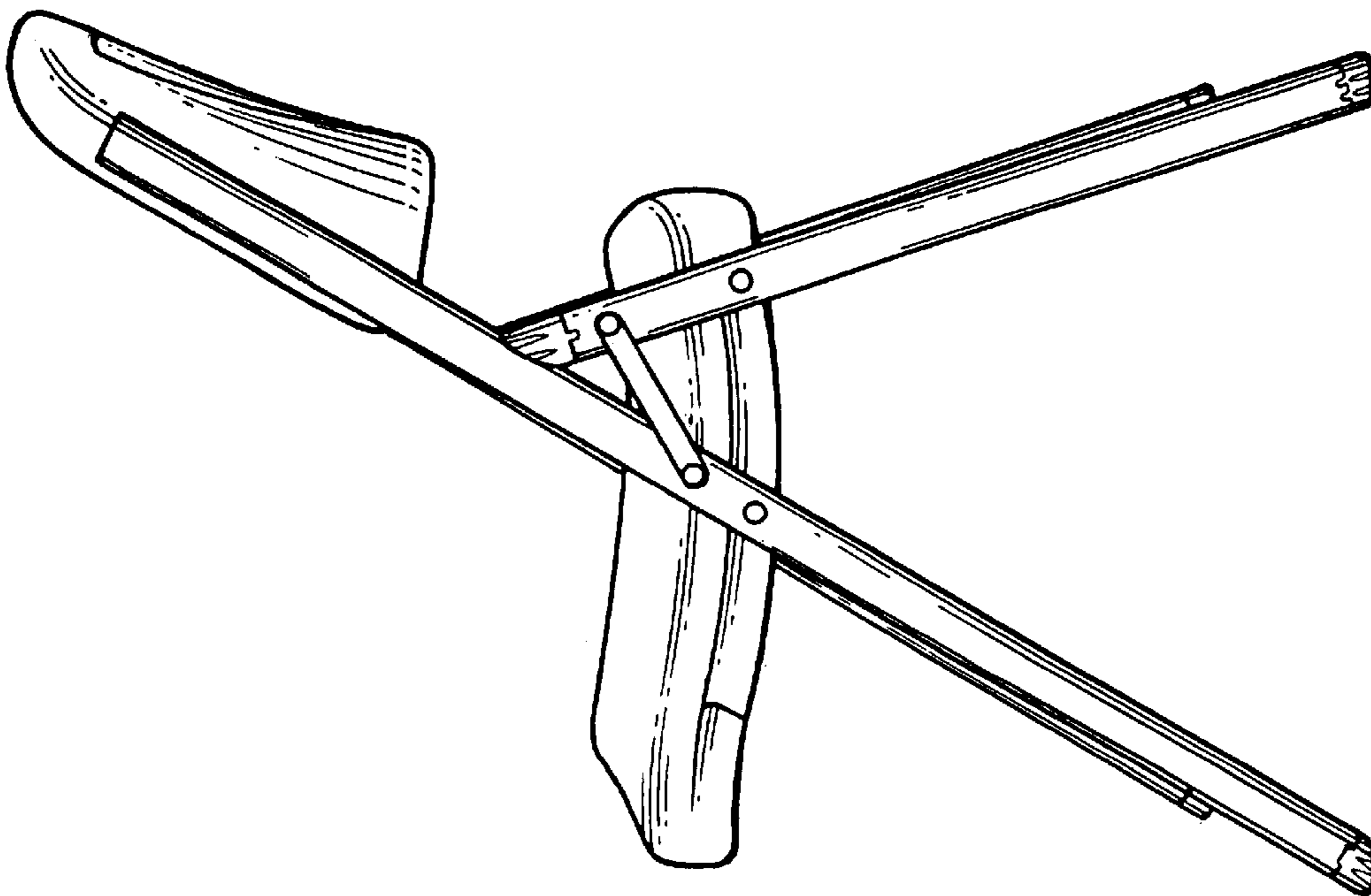

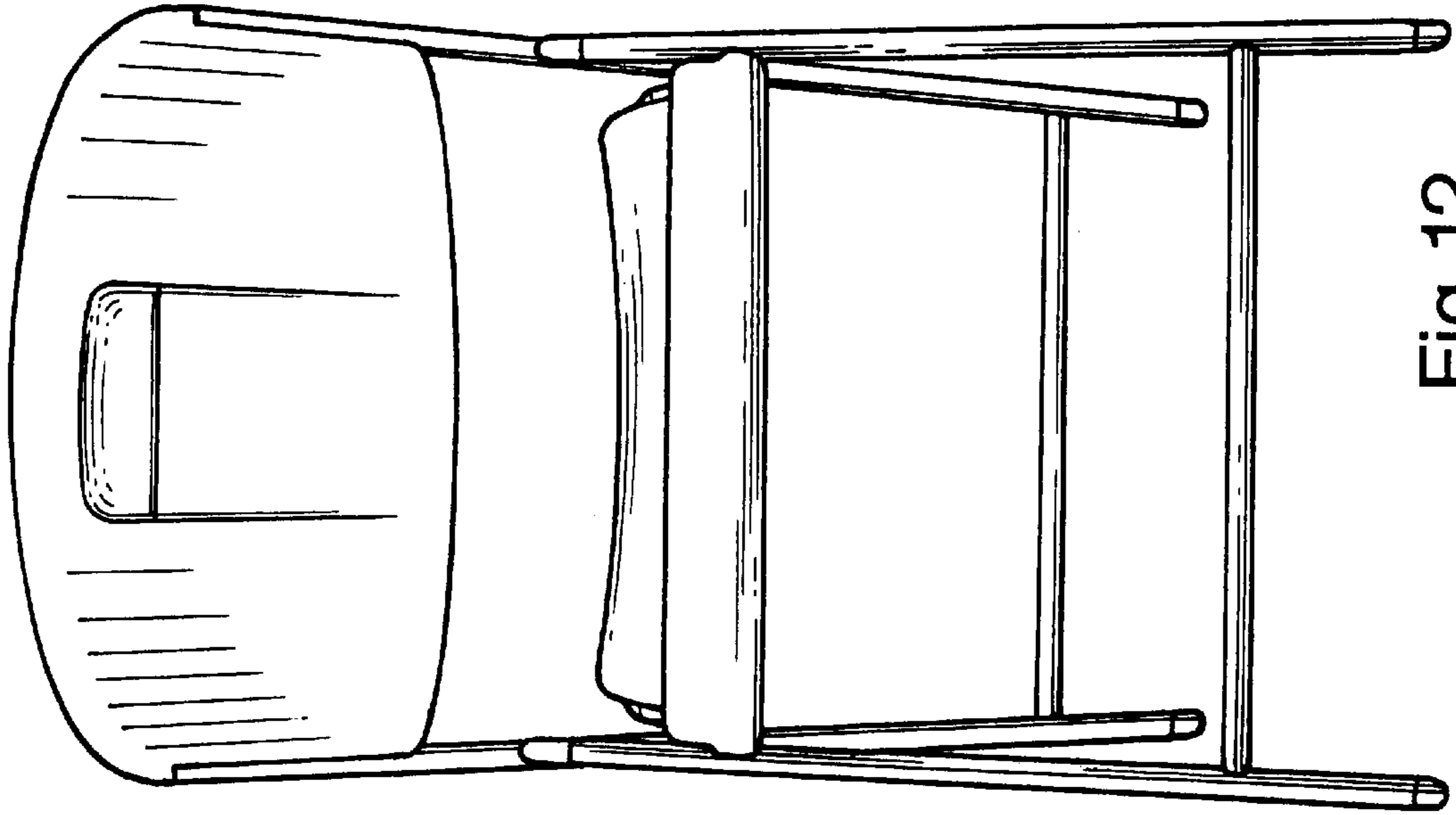

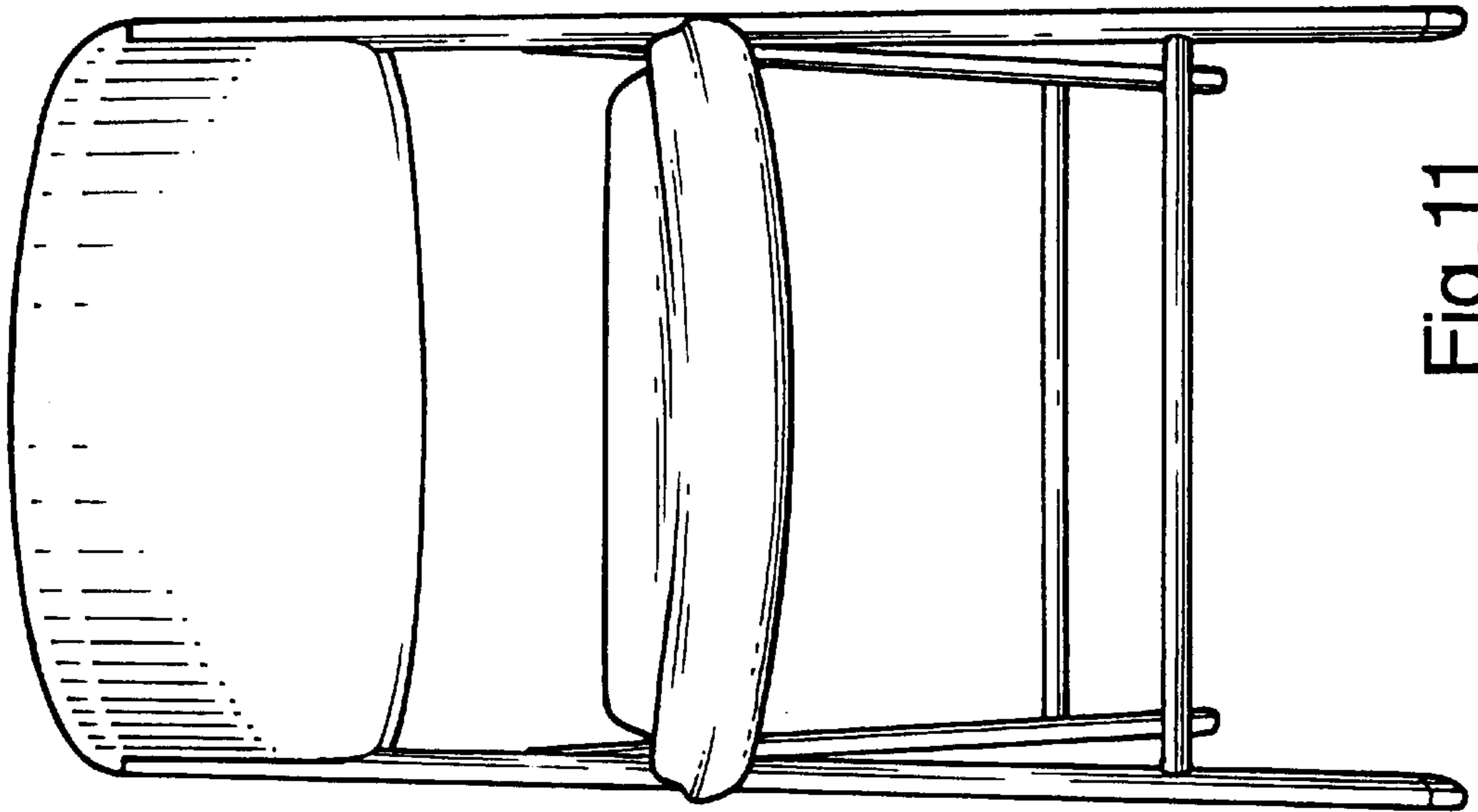

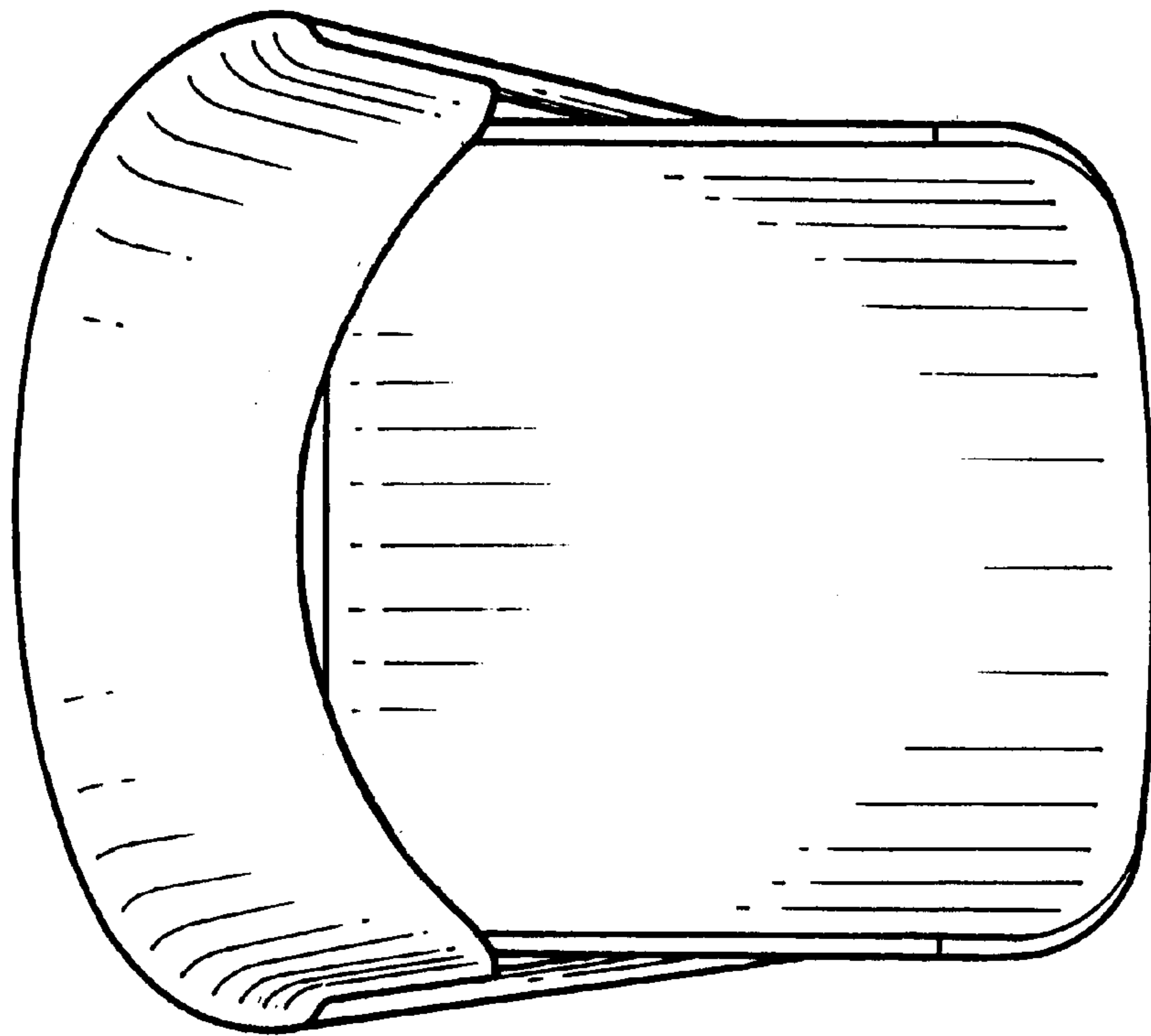

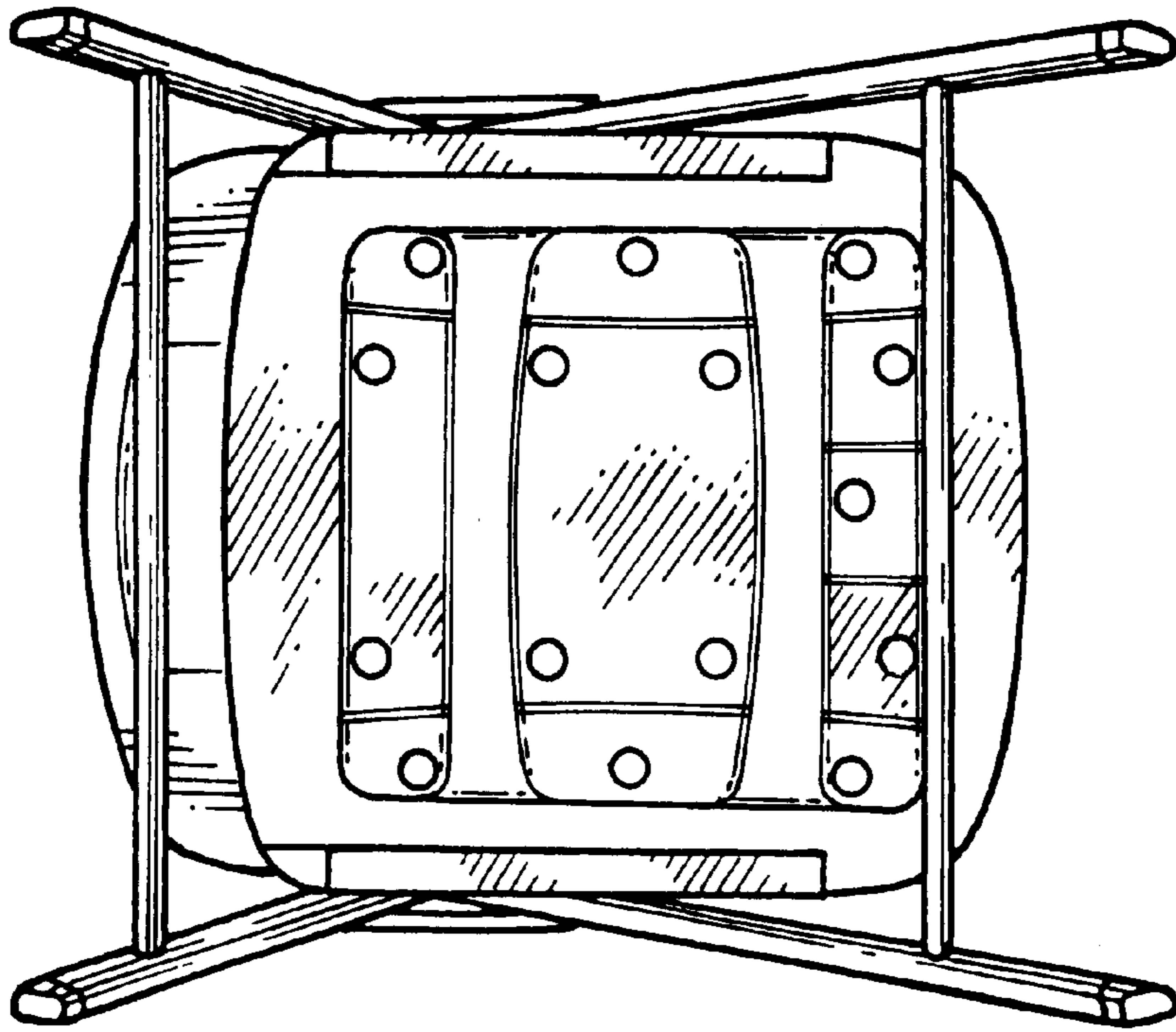
