(57) **CLAIM**

The ornamental design for a headrest pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of headrest pillow showing my design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevation view thereof;

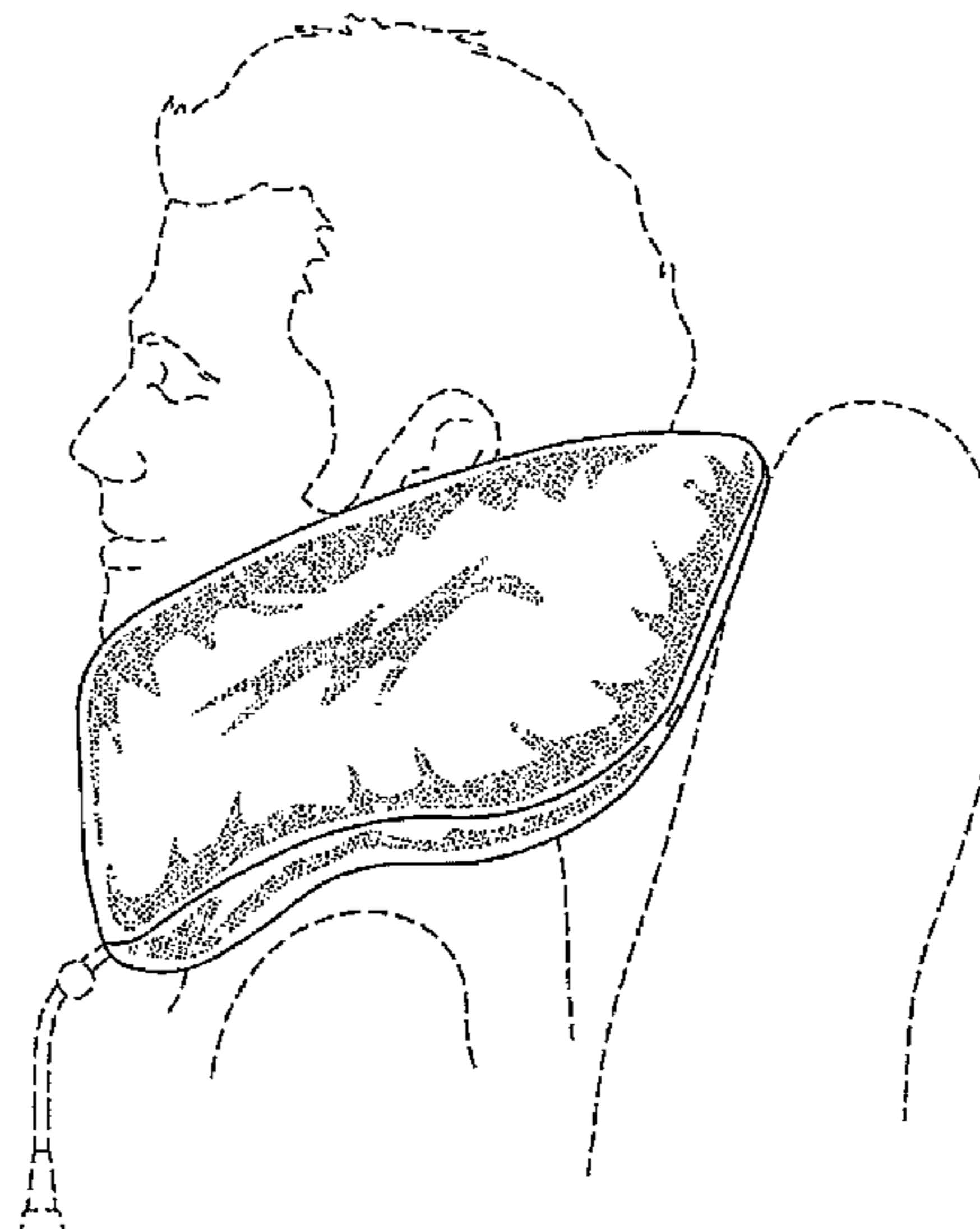
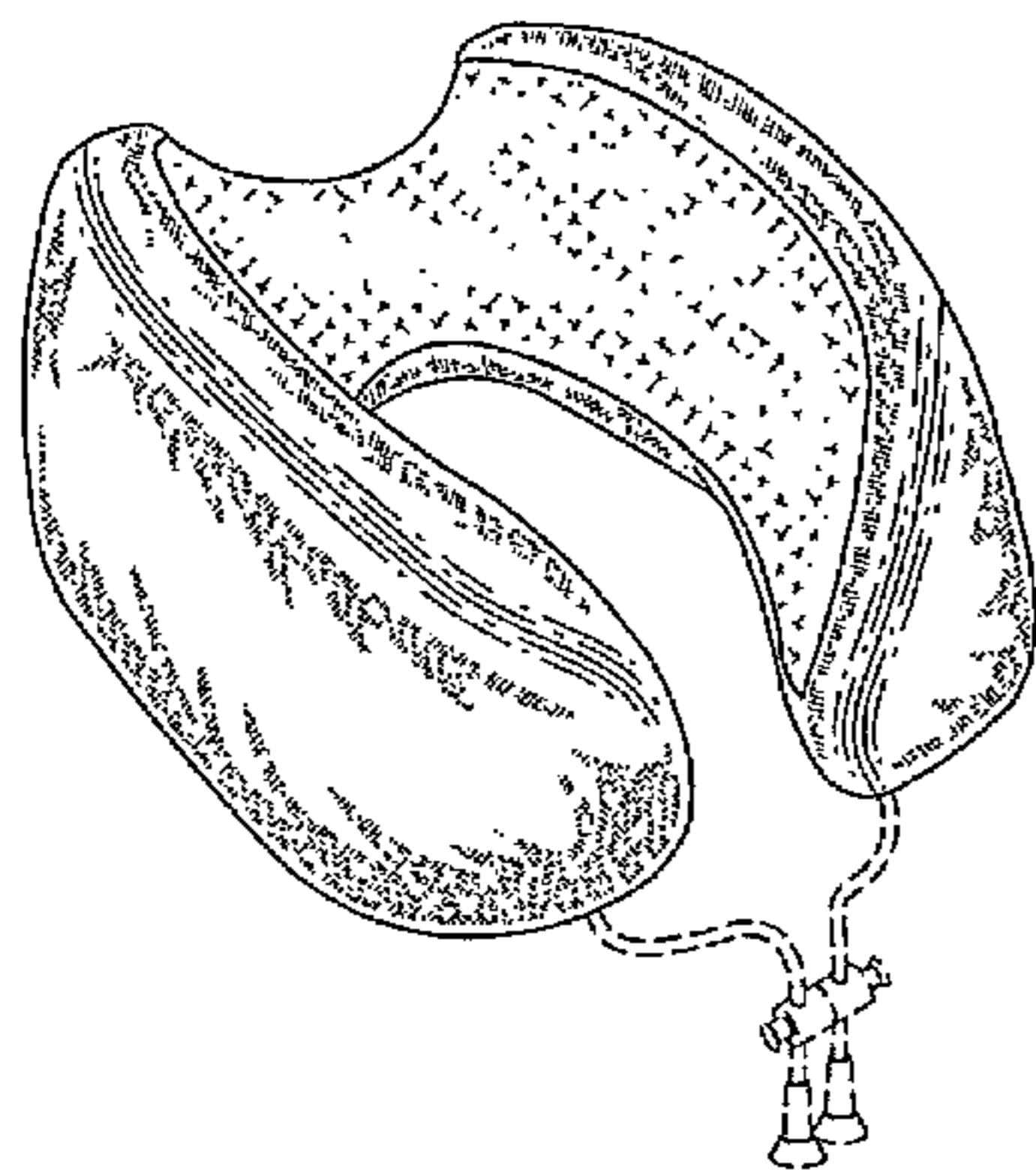
FIG. 5 is a rear elevation view thereof;

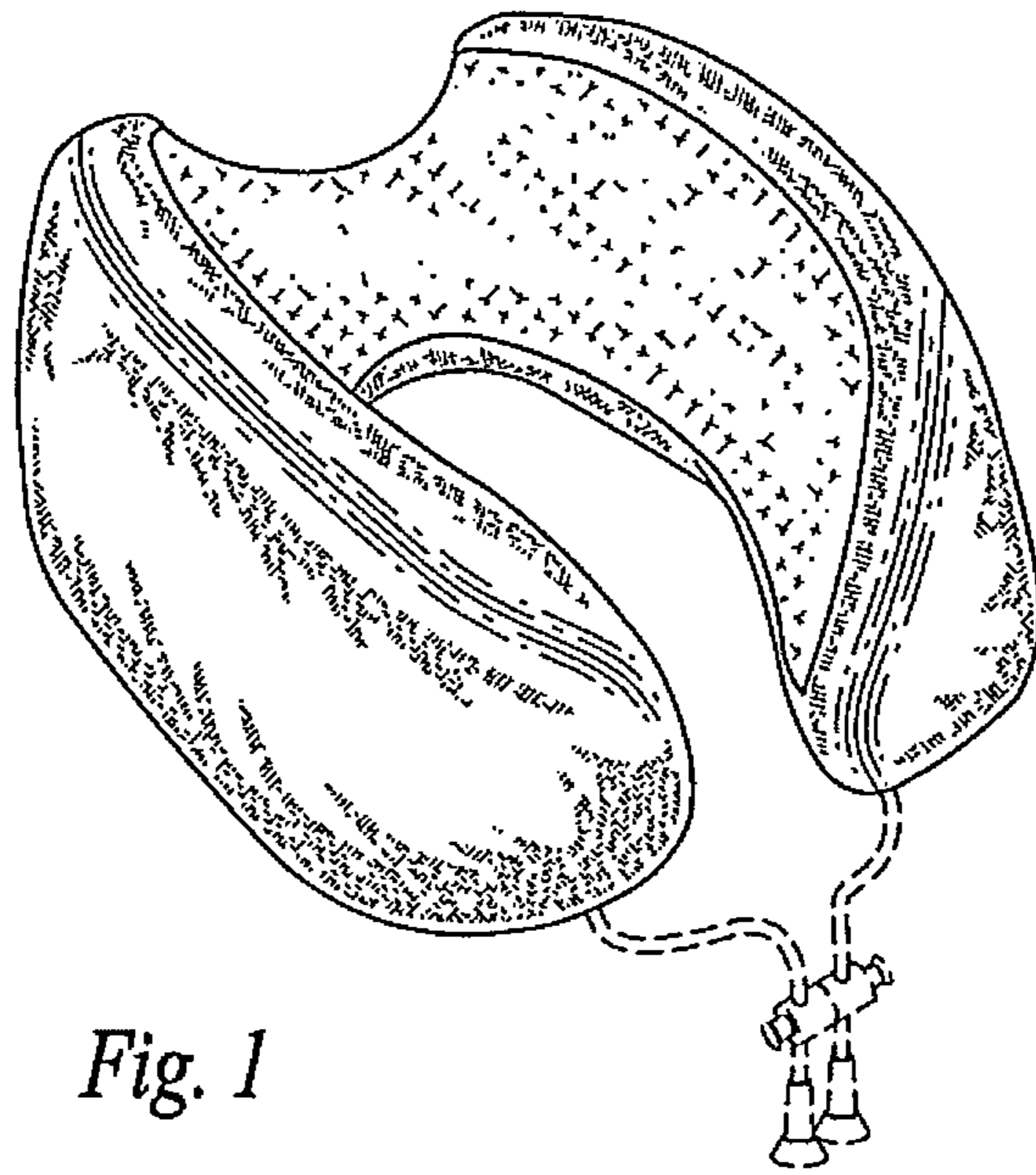

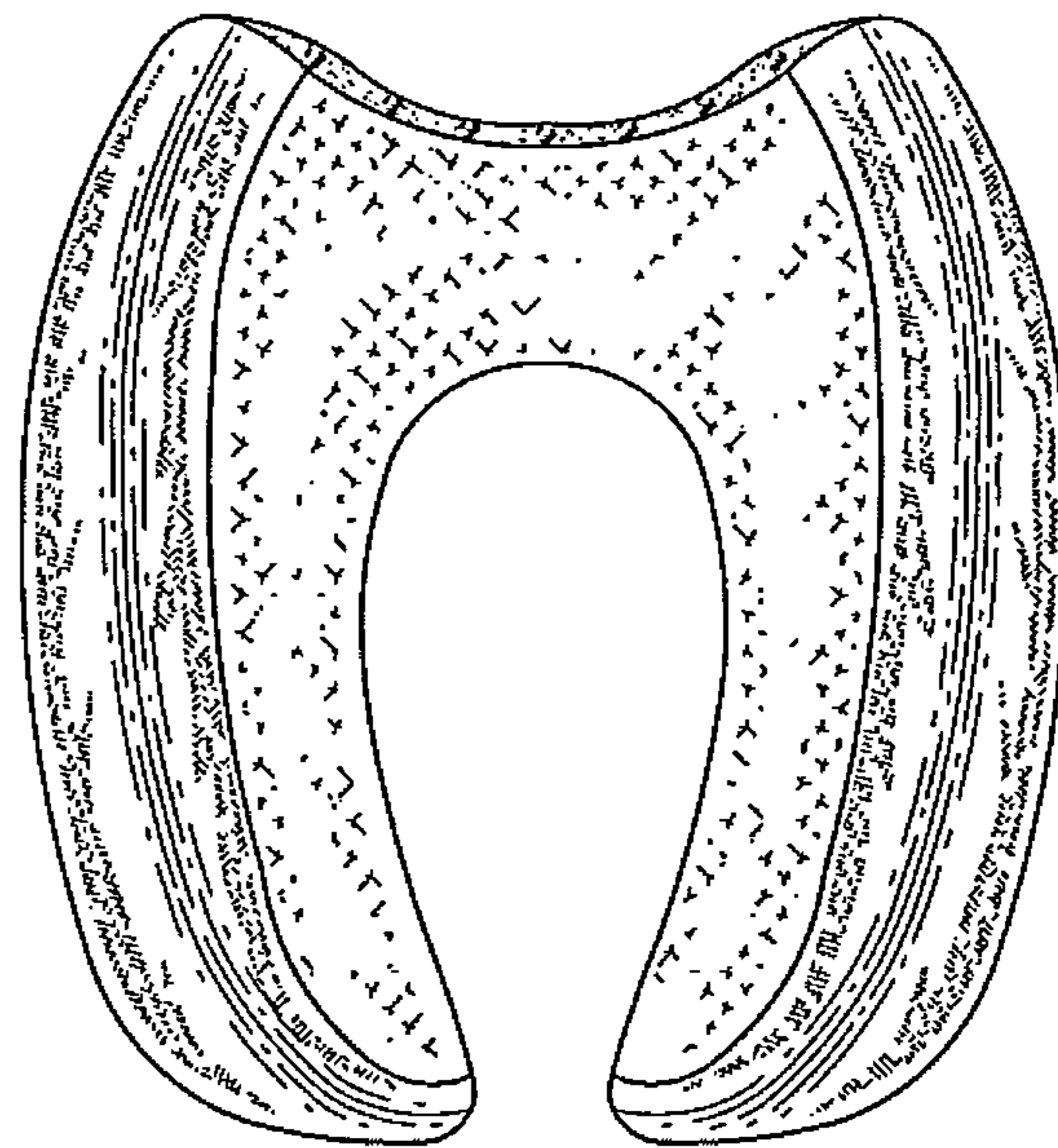

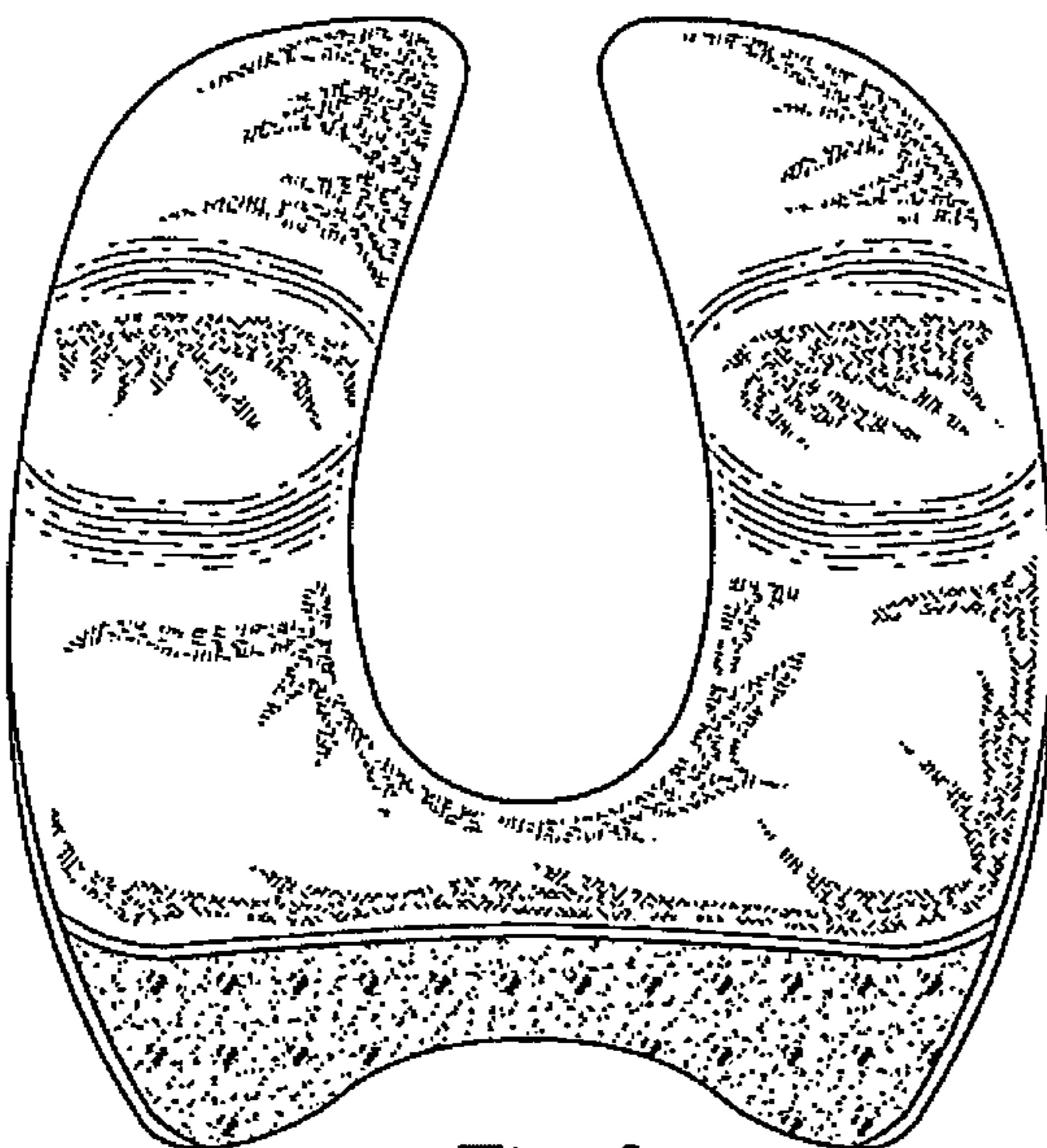

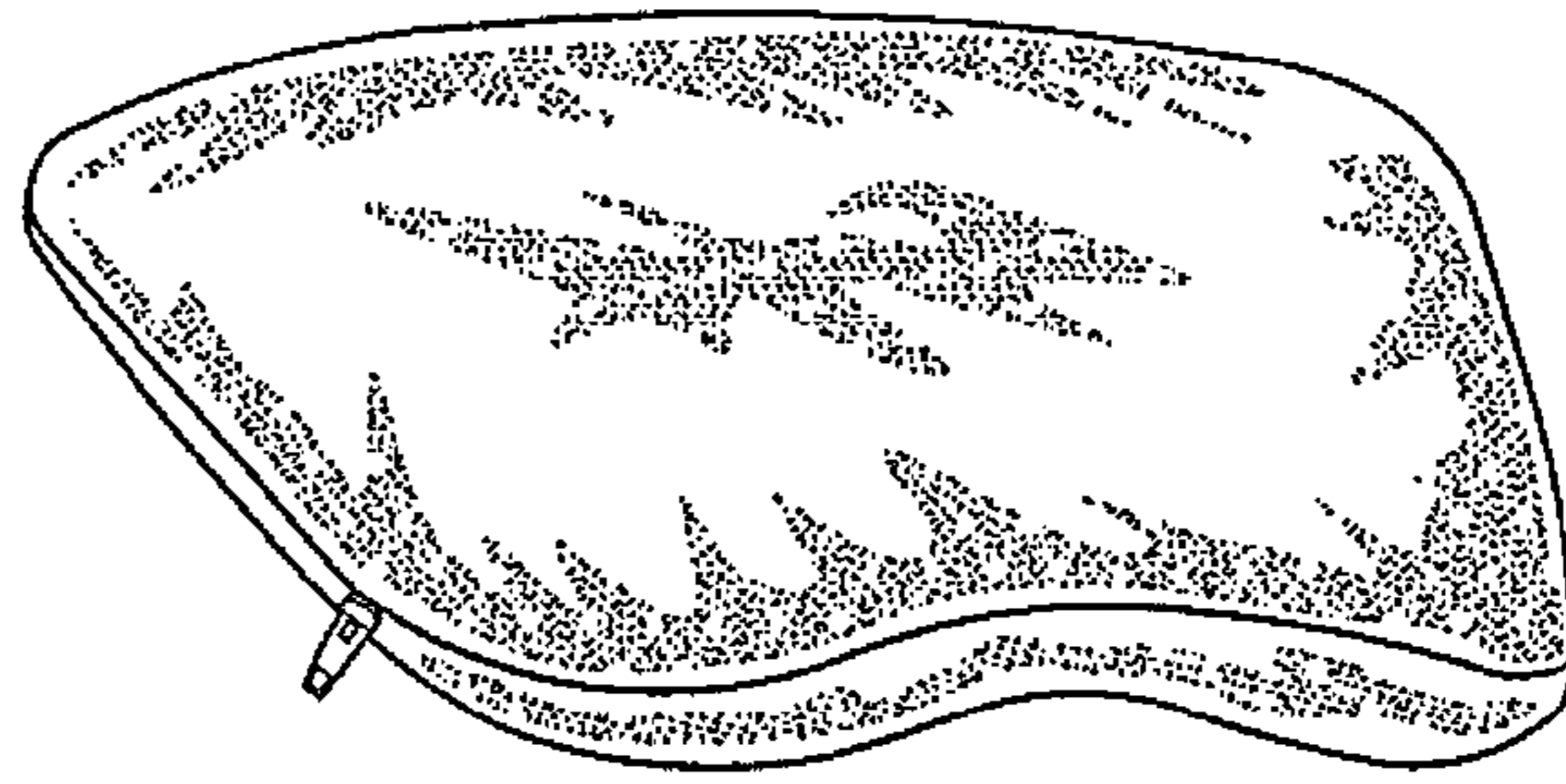

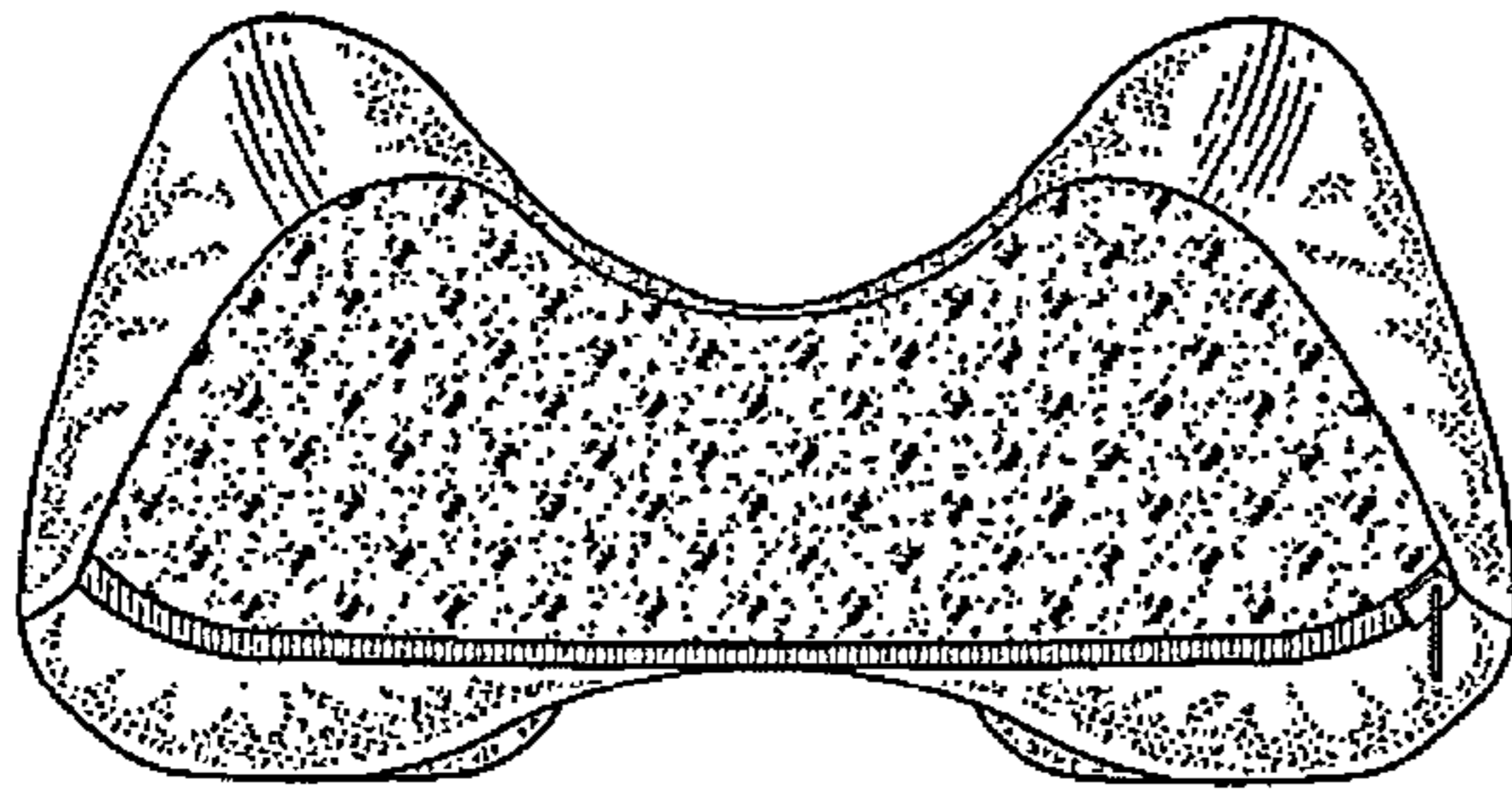

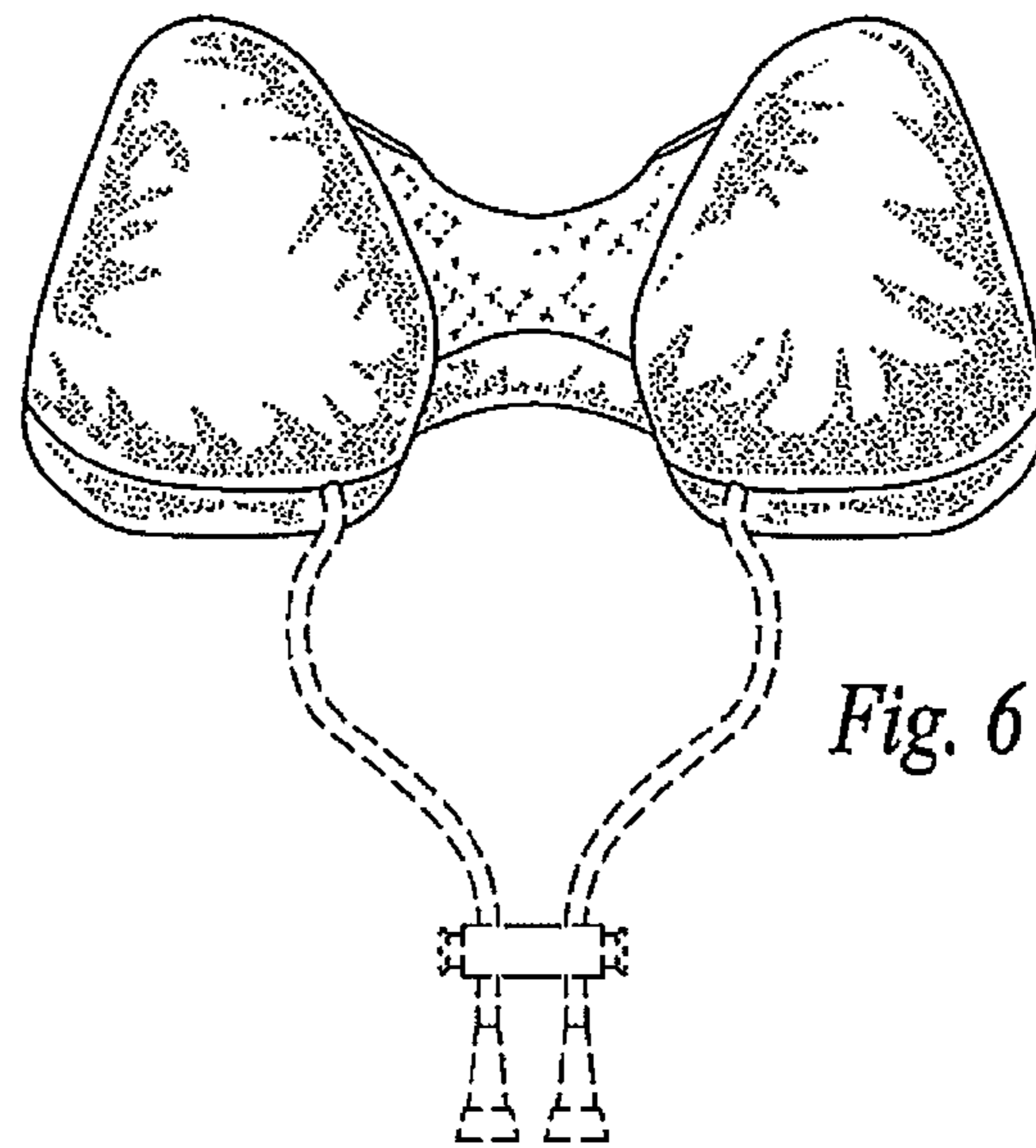

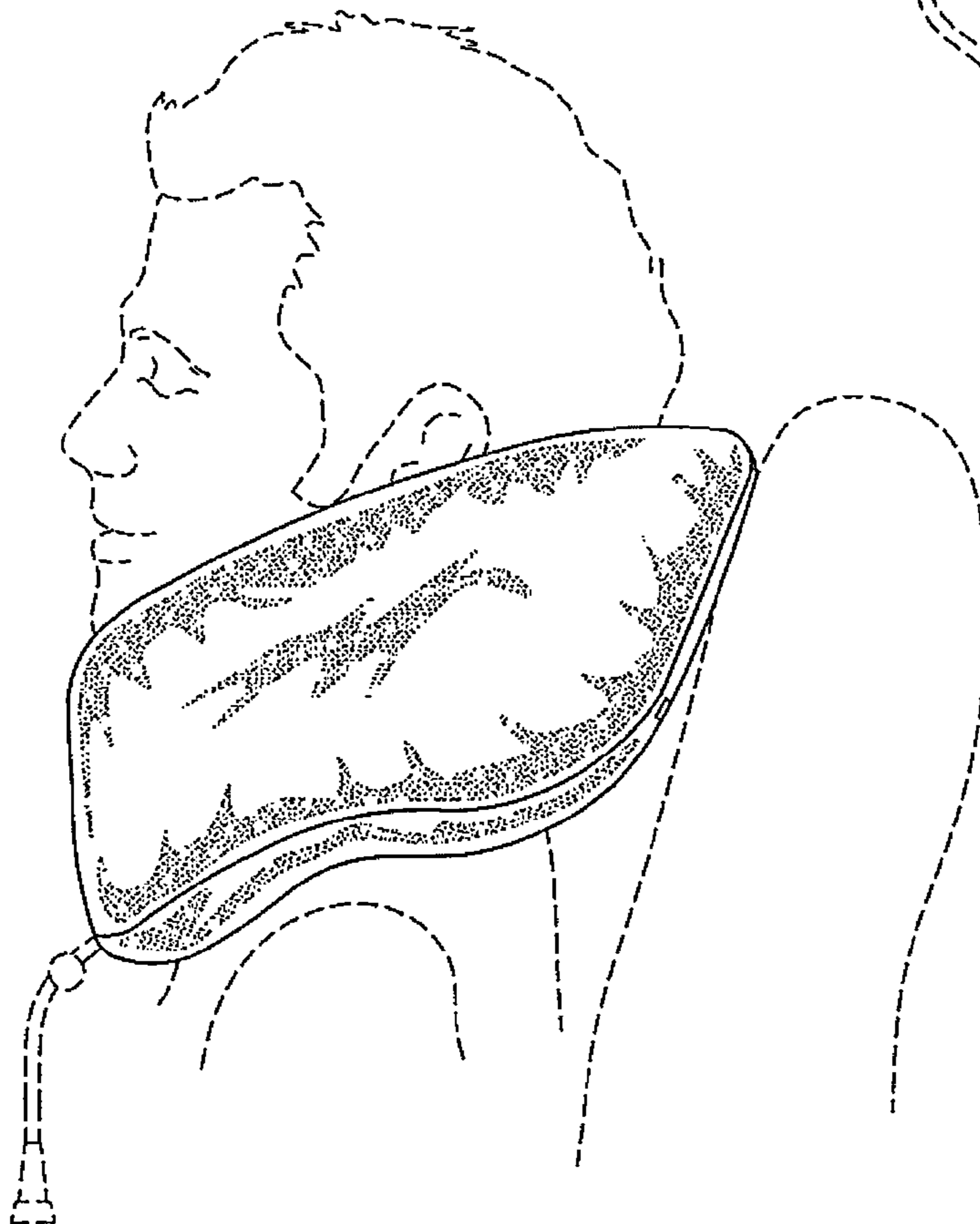
