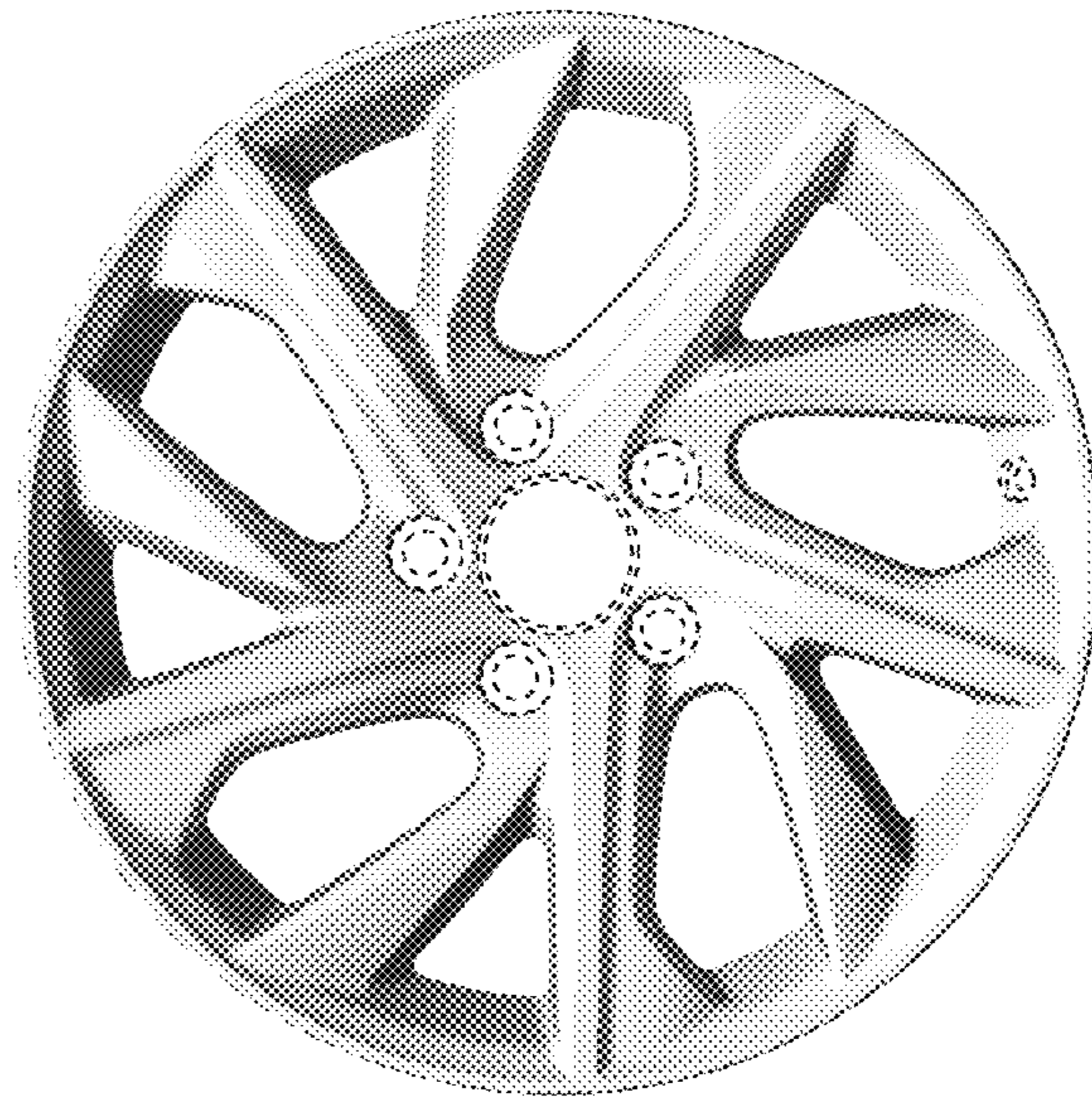
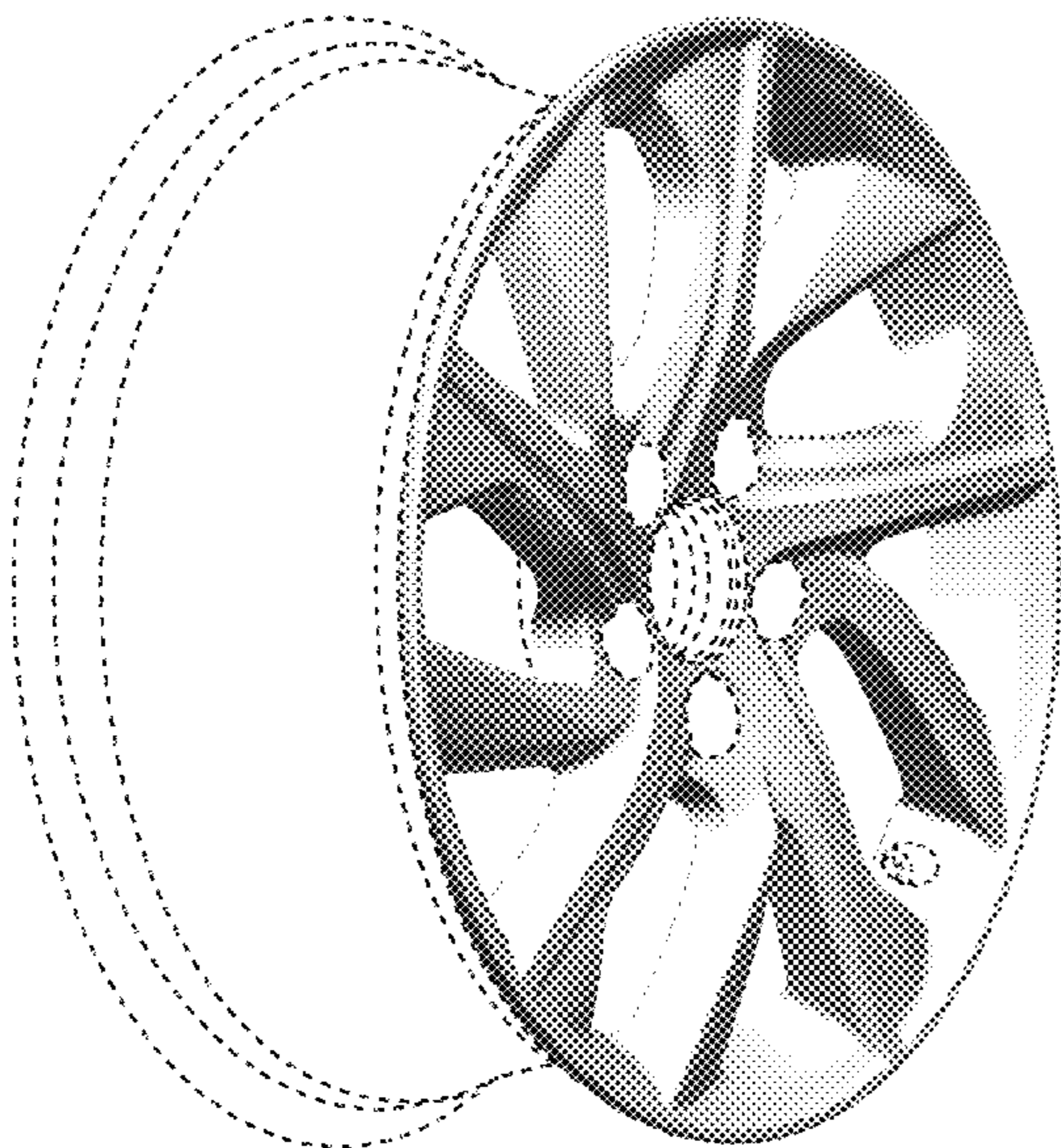
(57) **CLAIM**

The ornamental design for a wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a wheel showing our new design;
FIG. 2 is a front right perspective view of the design shown in FIG. 1;
FIG. 3 is a rear right perspective view of the design shown in FIG. 1;
FIG. 4 is a rear left perspective view of the design shown in FIG. 1;

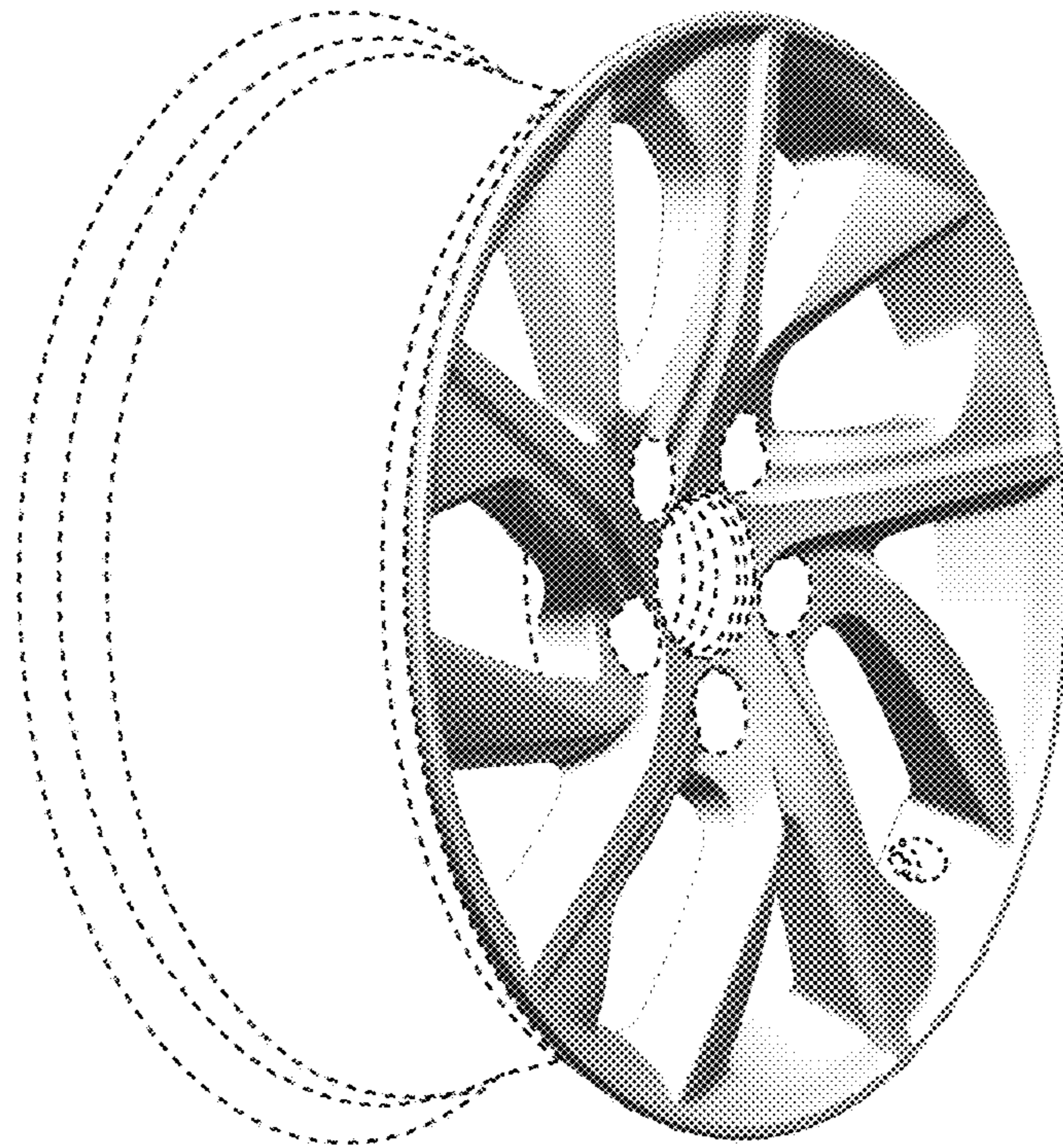

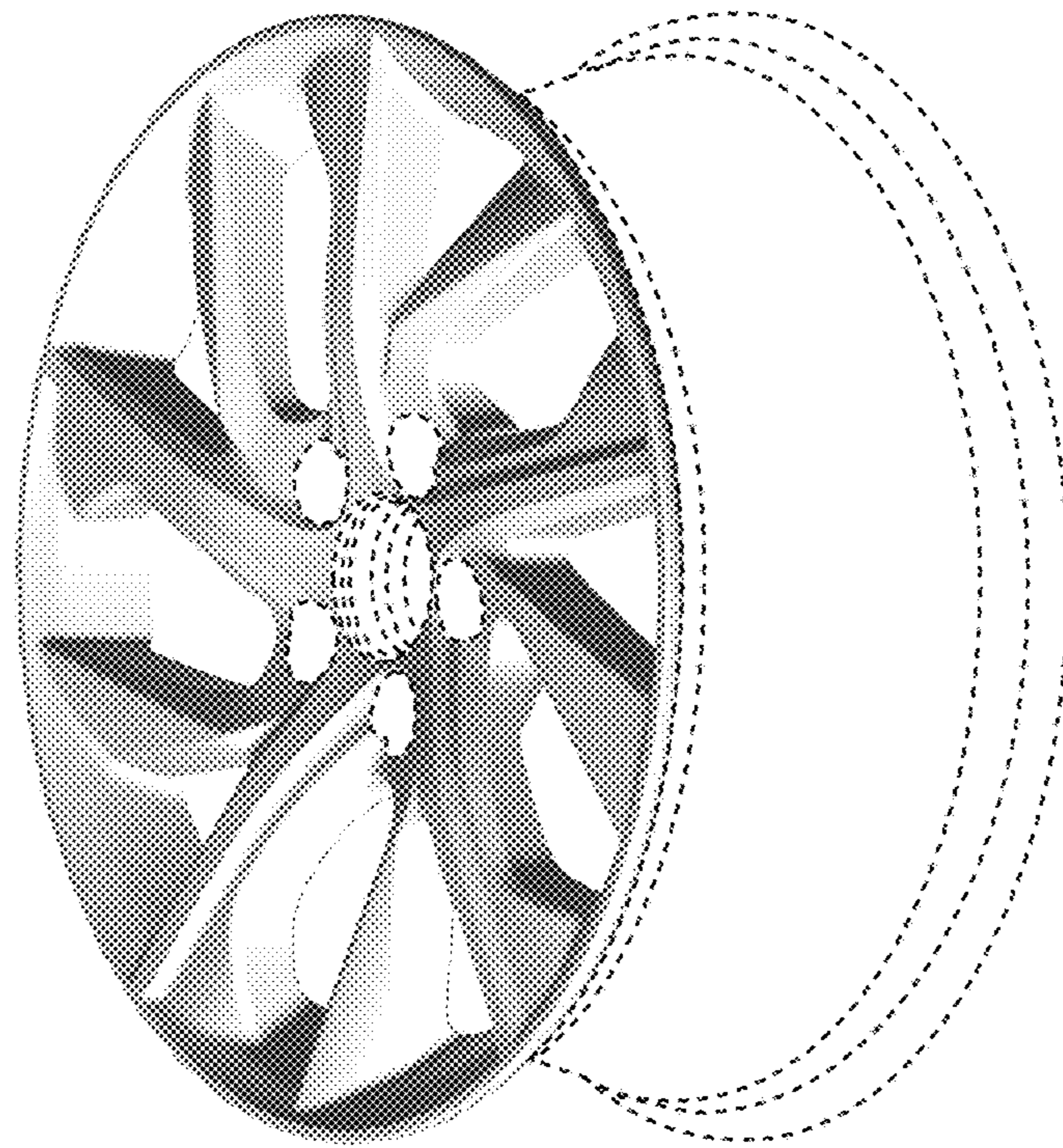

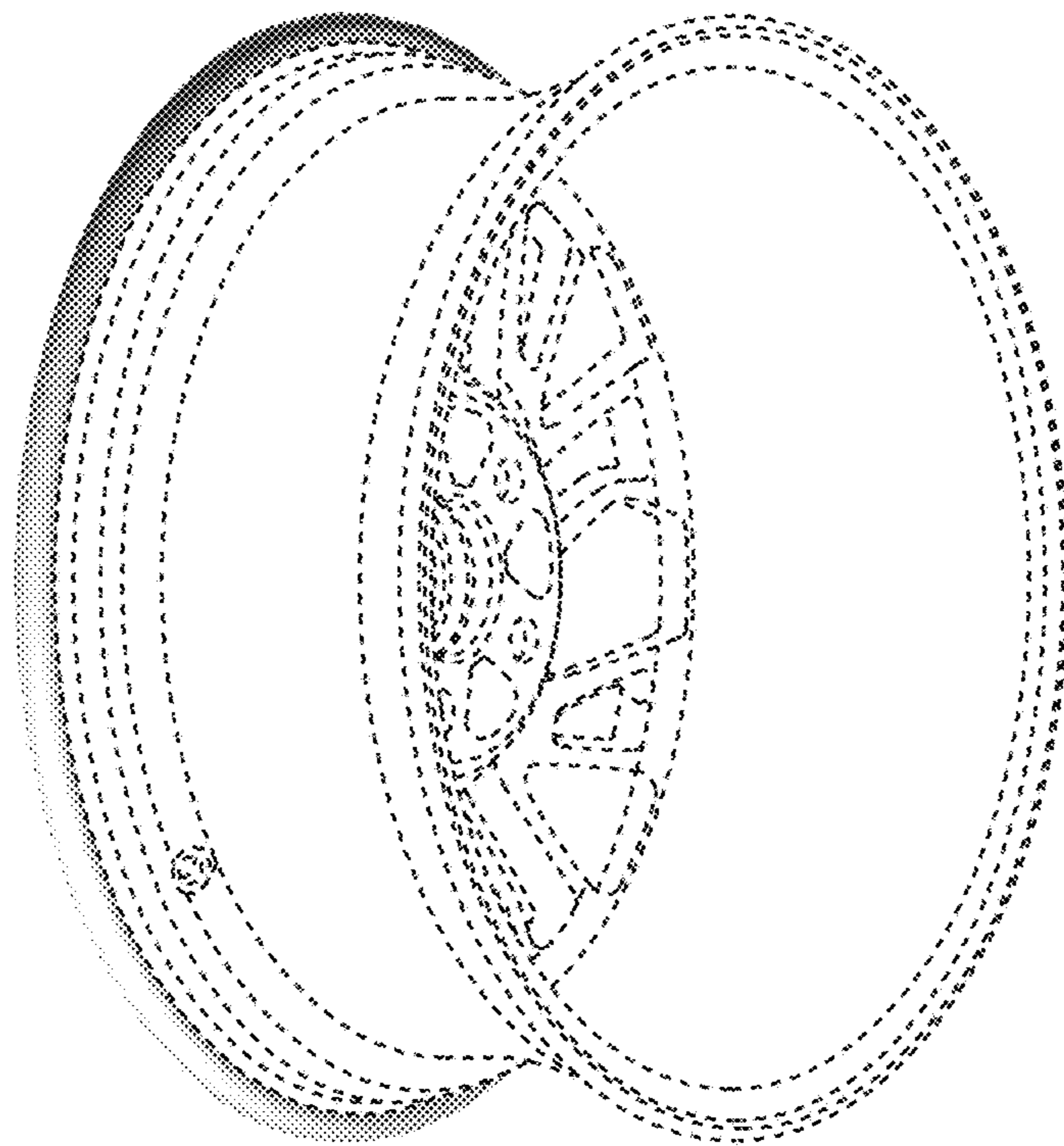

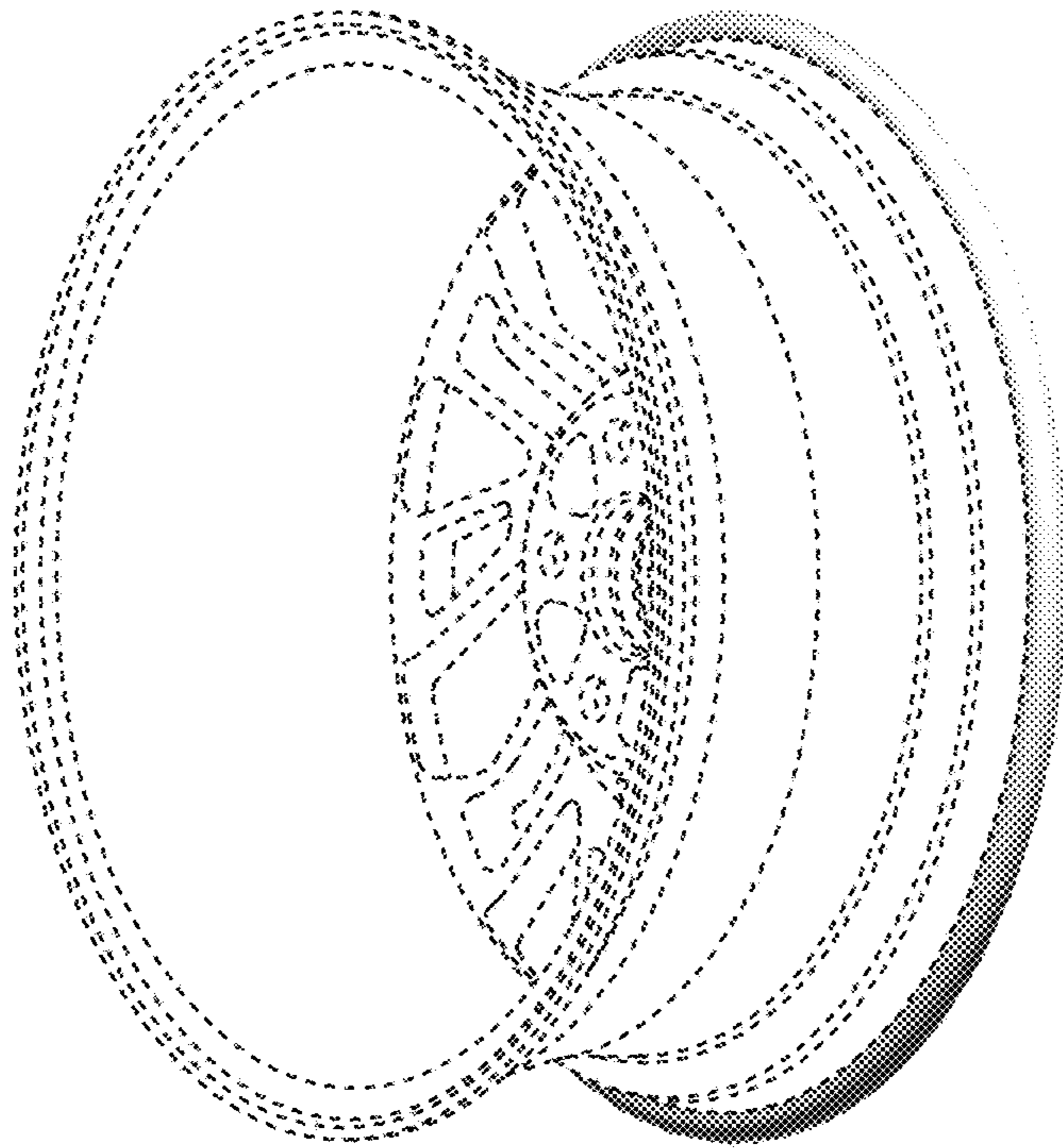

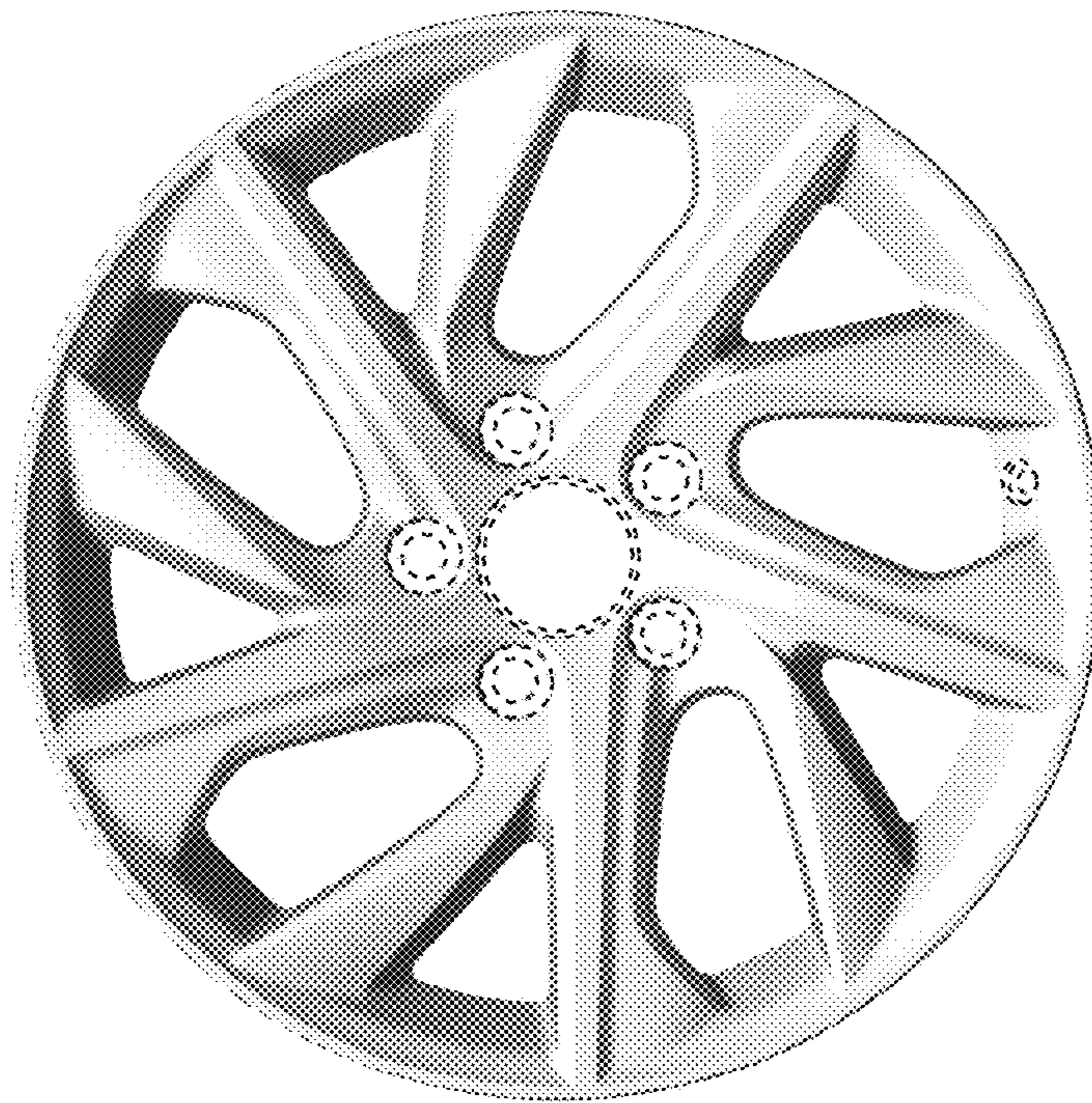

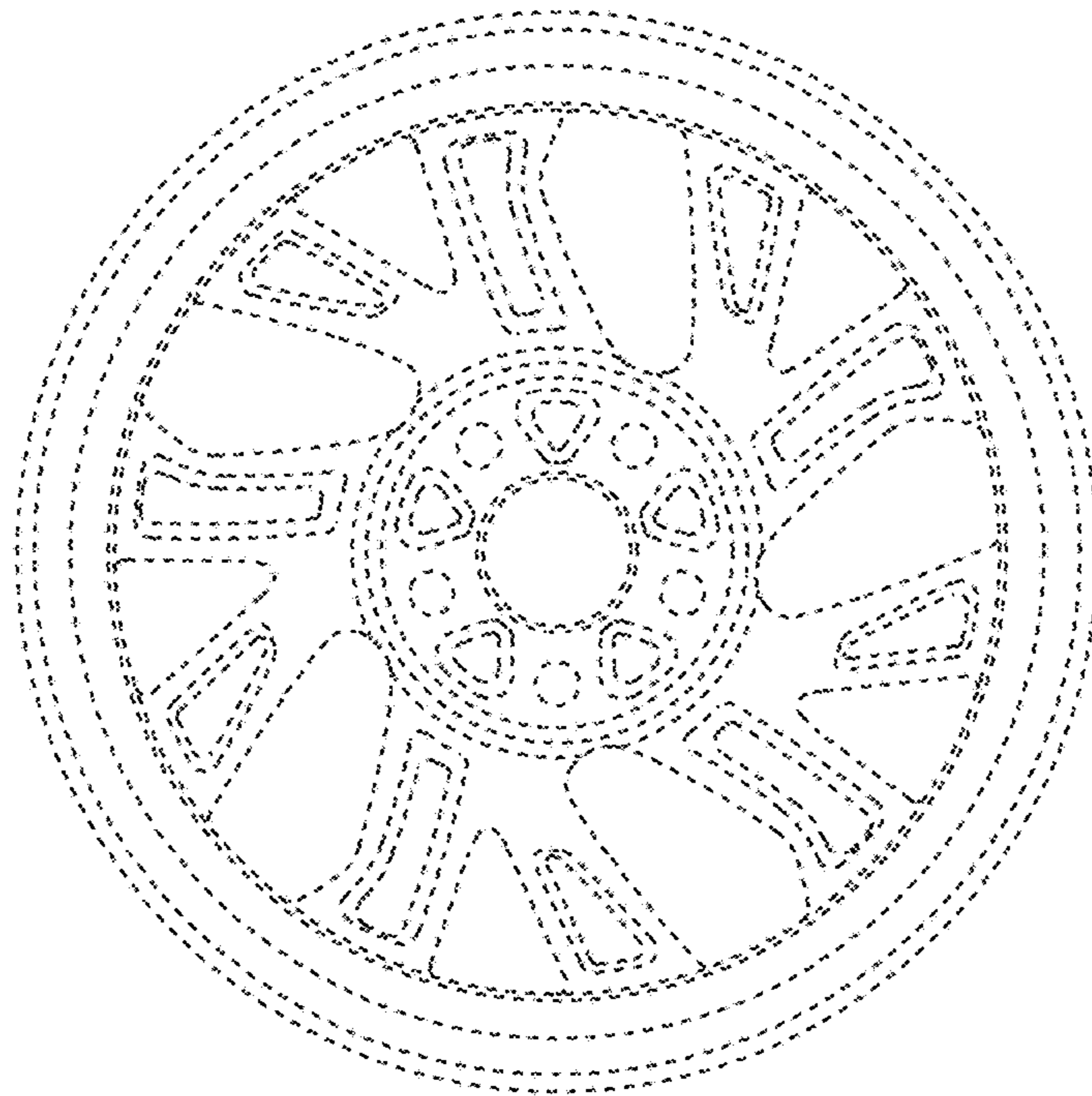

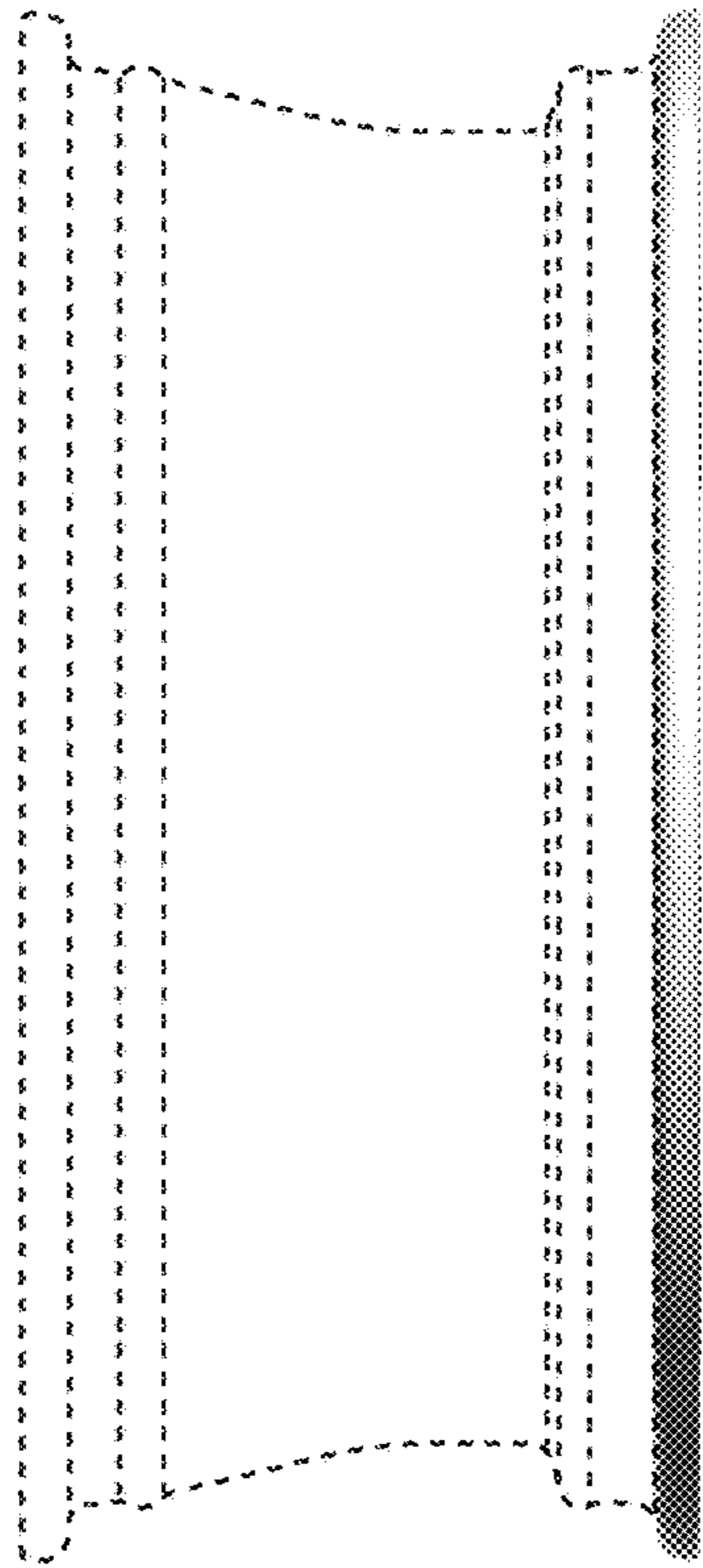

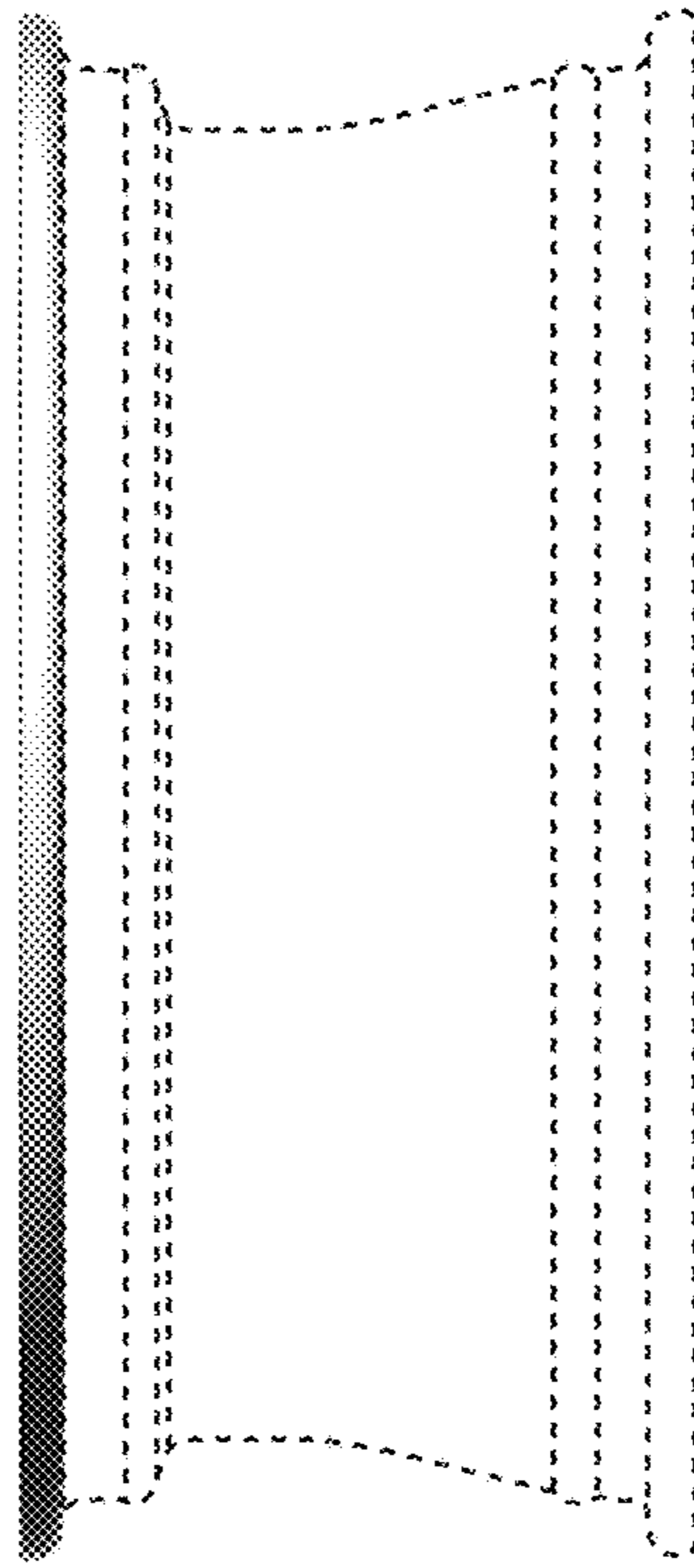

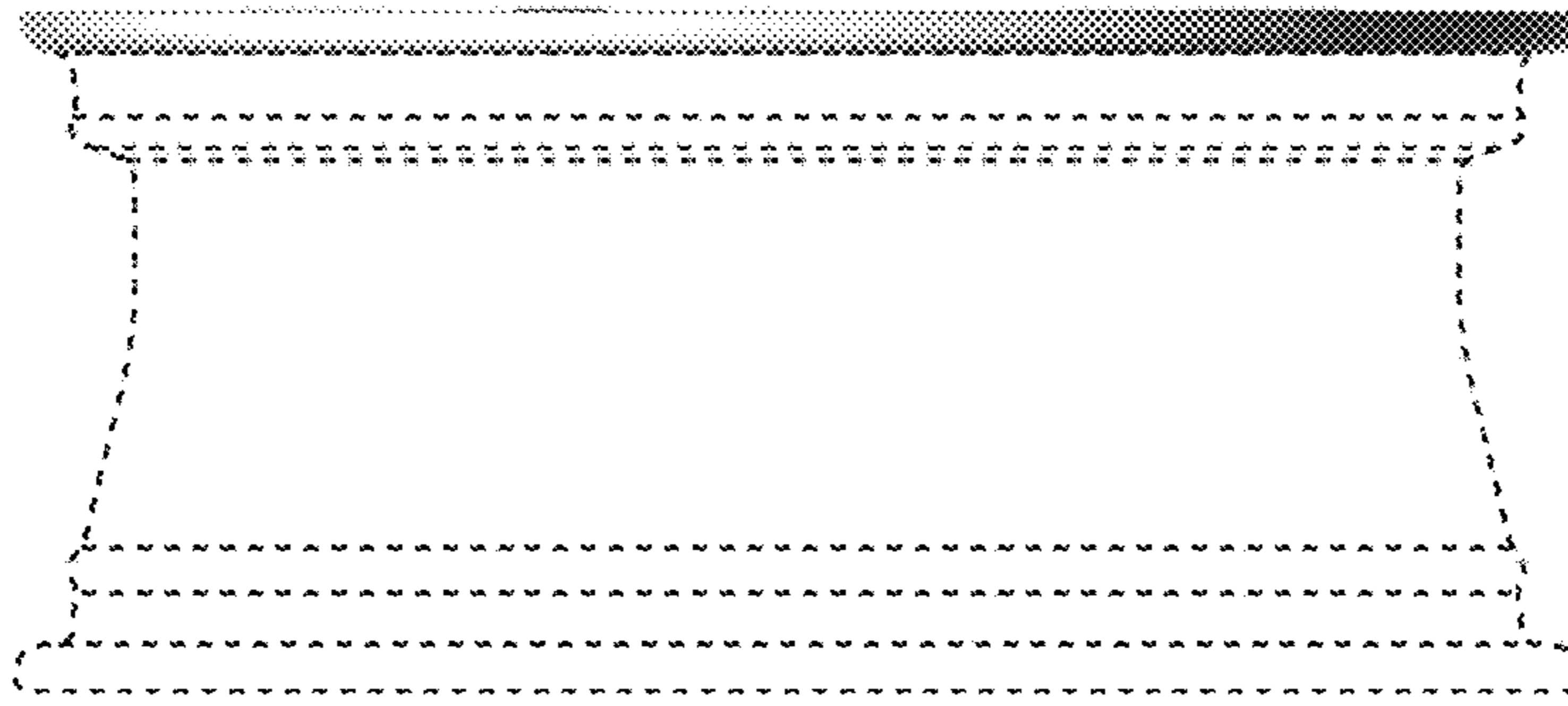

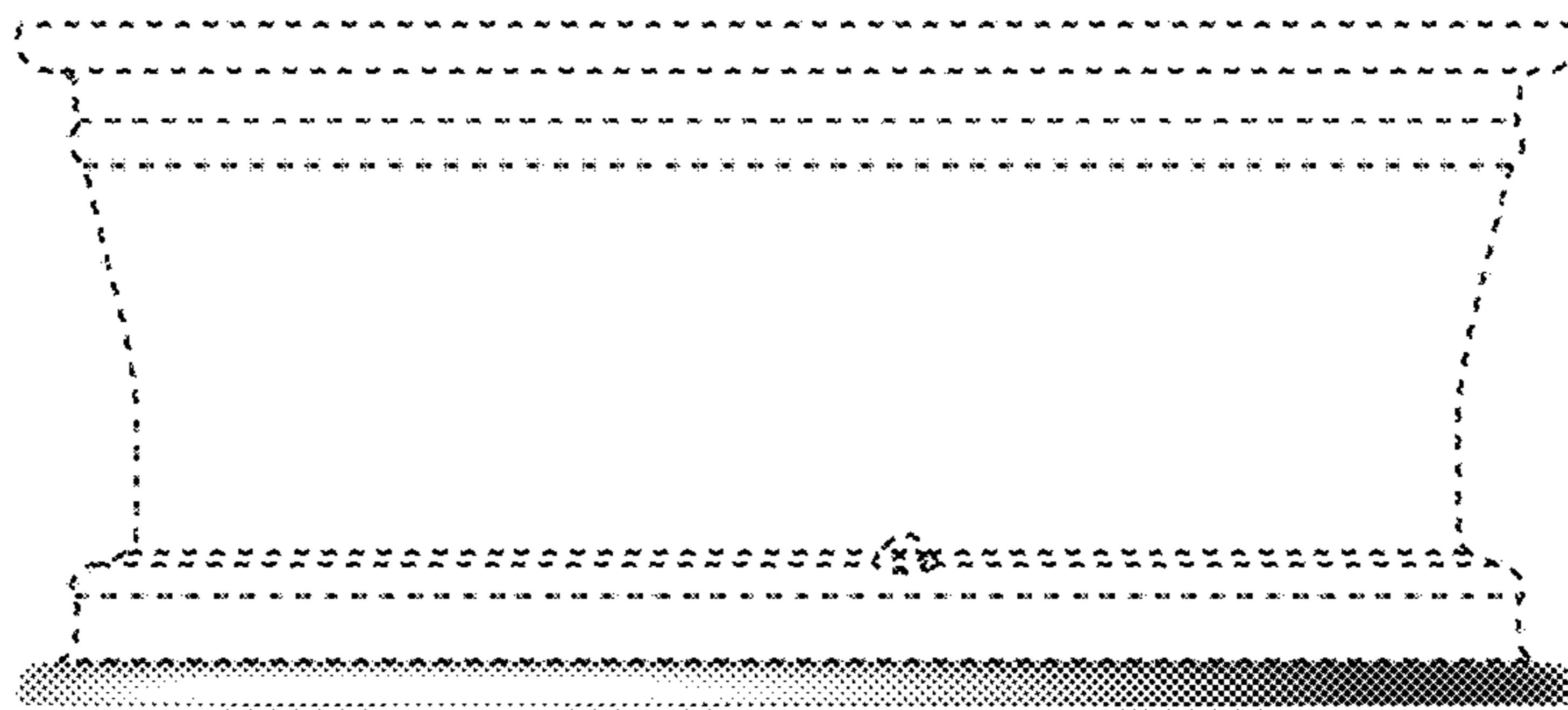
