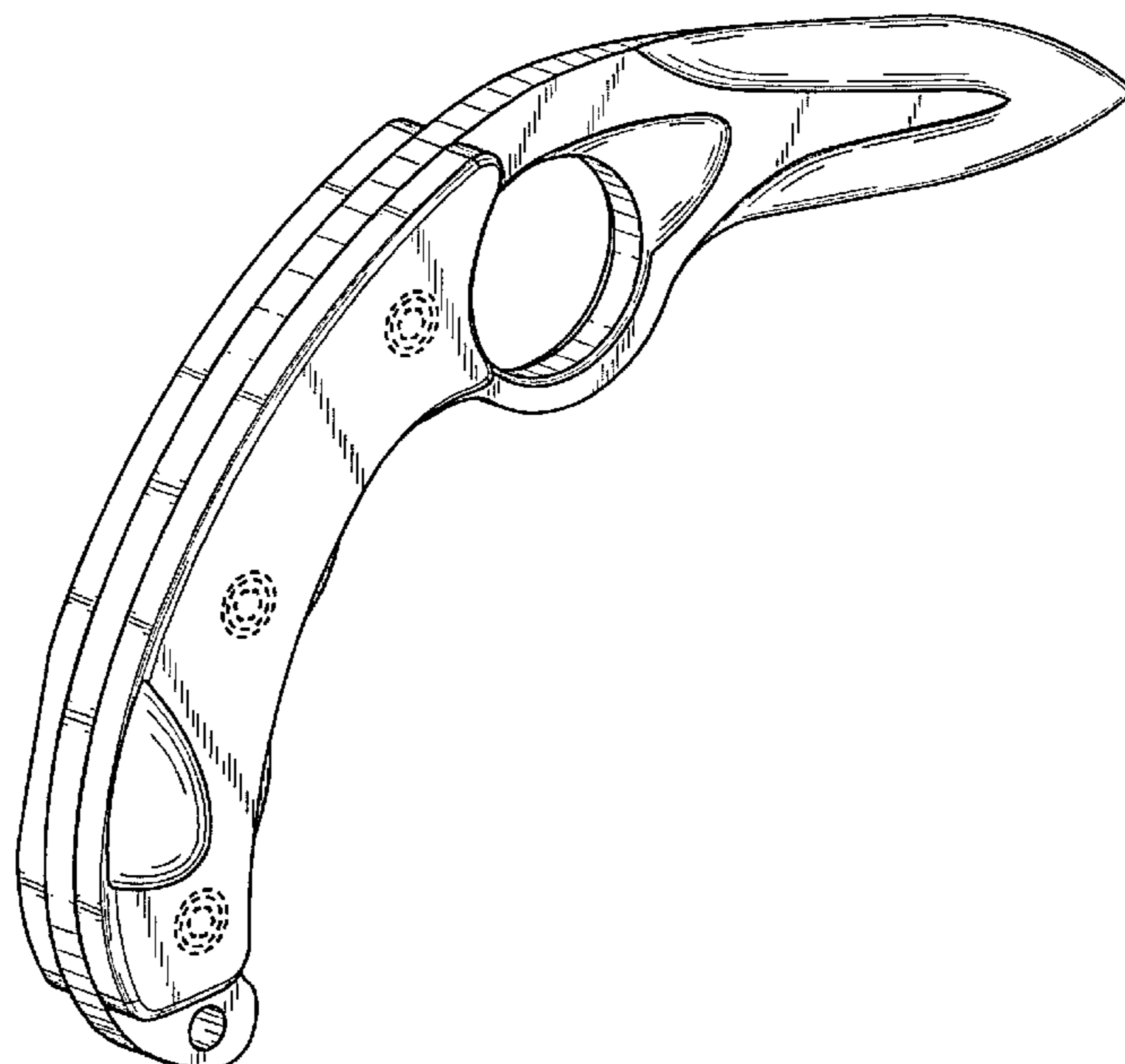

(57) **CLAIM**  
The ornamental design for a pistol grip knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the pistol grip knife.  
FIG. 2 is a side elevational view of the pistol grip knife with both sides being symmetrical.  
FIG. 3 is a front elevation view of the pistol grip knife blade pointed forward.  
FIG. 4 is a rear elevation view with the blade of the pistol grip knife blade pointed away.  
FIG. 5 is a top plan view of the pistol grip knife.  
FIG. 6 is a bottom plan view of the pistol grip knife.  
FIG. 7 is a perspective view of an alternate embodiment of the pistol grip knife shown in FIG. 1.  
FIG. 8 is a side elevational view of the pistol grip knife with both sides being symmetrical.  
FIG. 9 is a front elevation view with the alternate embodiment of the pistol grip knife blade pointed toward the viewer.  
FIG. 10 is a rear elevation view with the alternate embodiment of the pistol grip knife blade pointed away.  
FIG. 11 is a top plan view of the alternate embodiment of the pistol grip knife; and,  
FIG. 12 is a bottom plan view of the alternate embodiment of the pistol grip knife.  
The broken line showing of environment in the drawings is included for the purpose of illustrating only and forms no part of the claimed design.

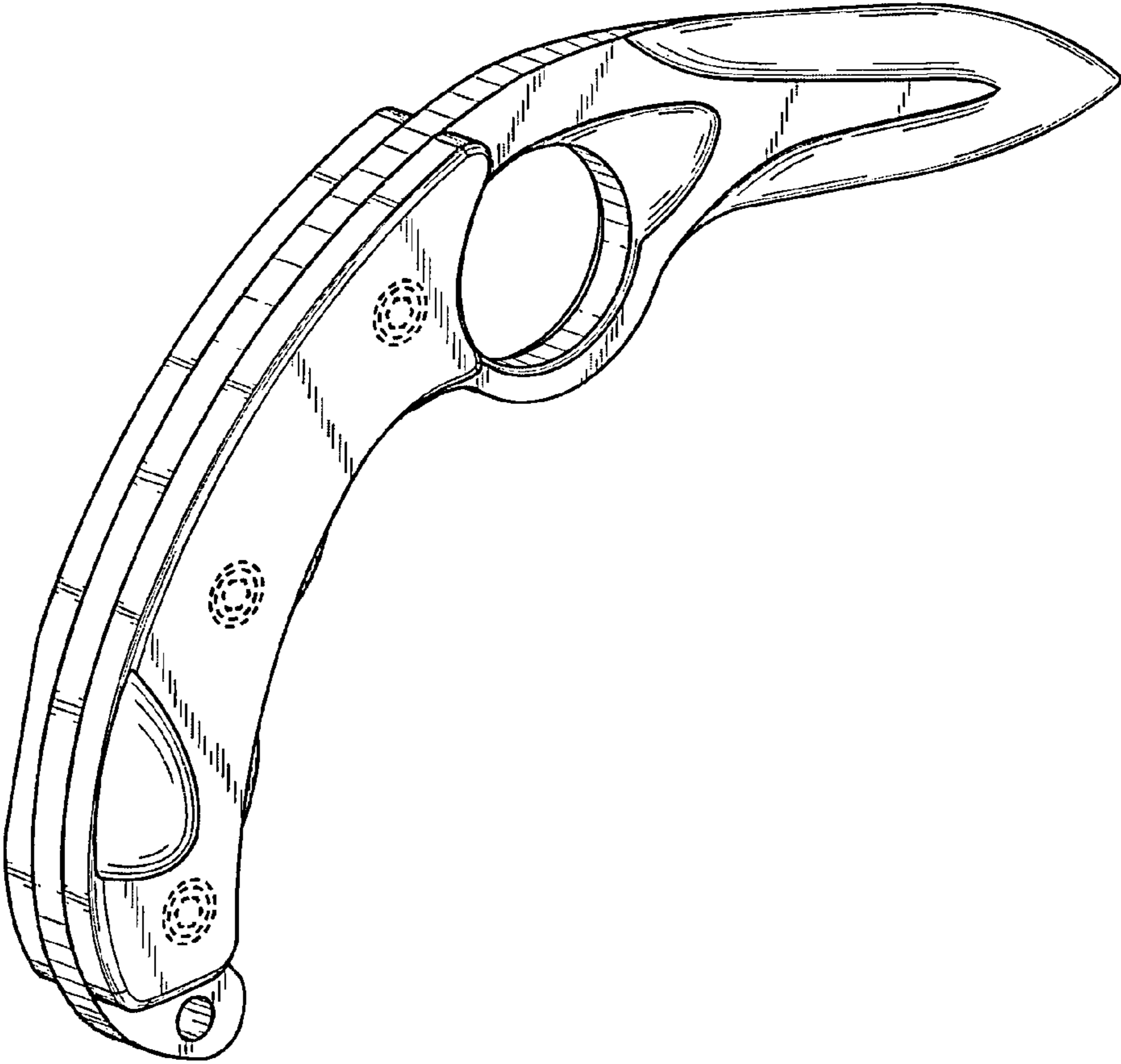

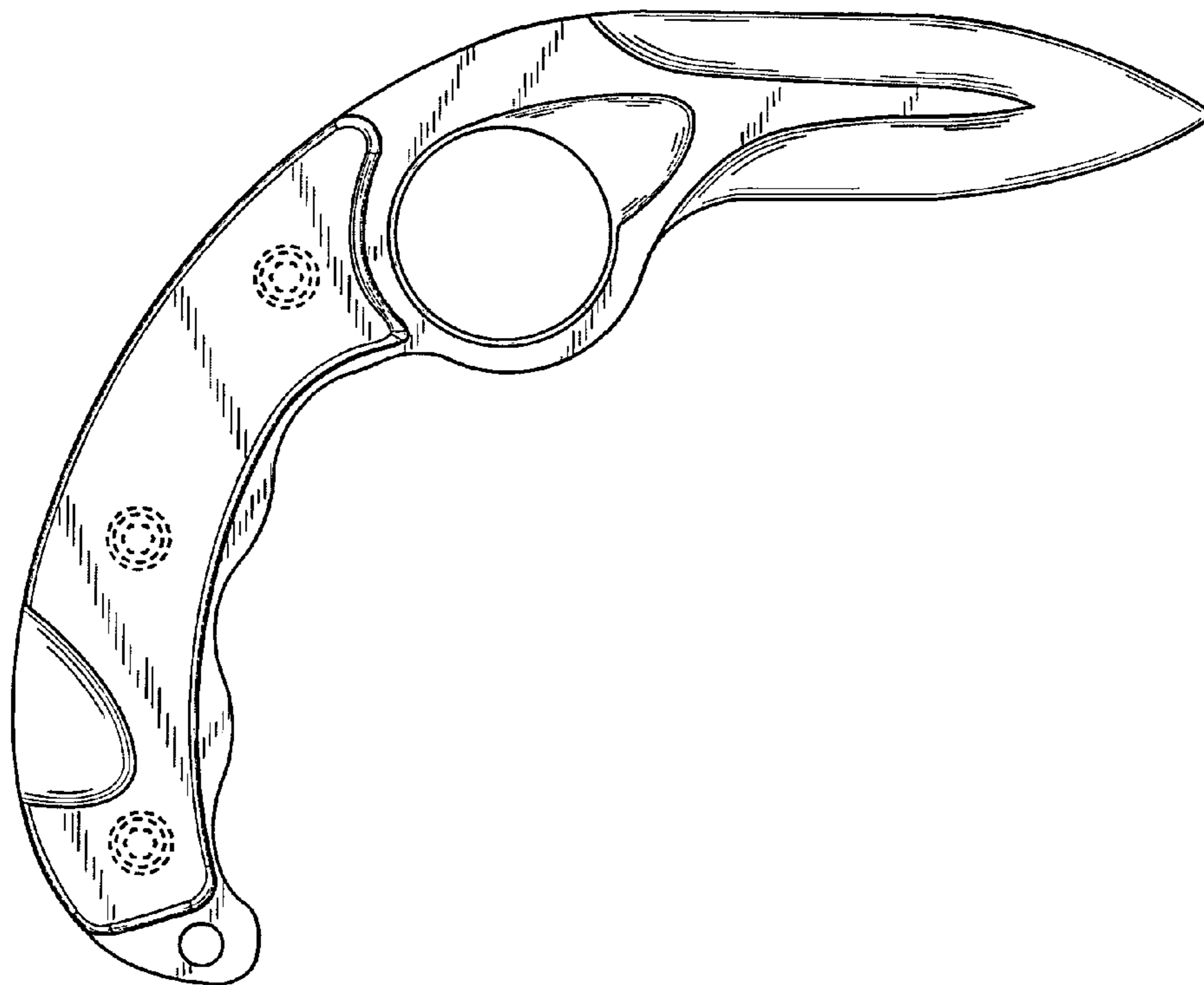

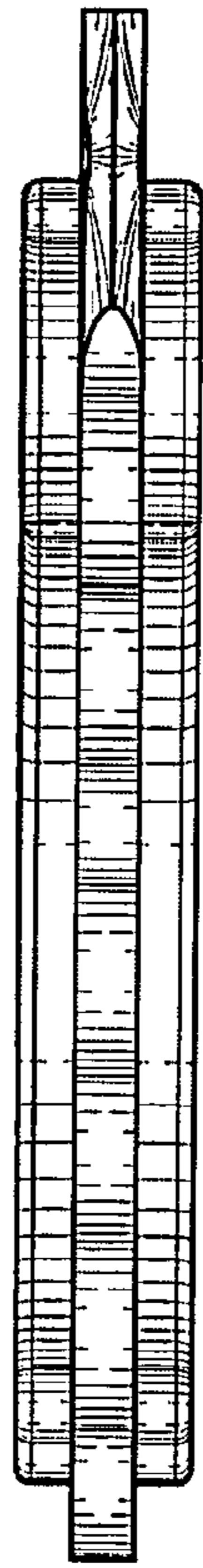

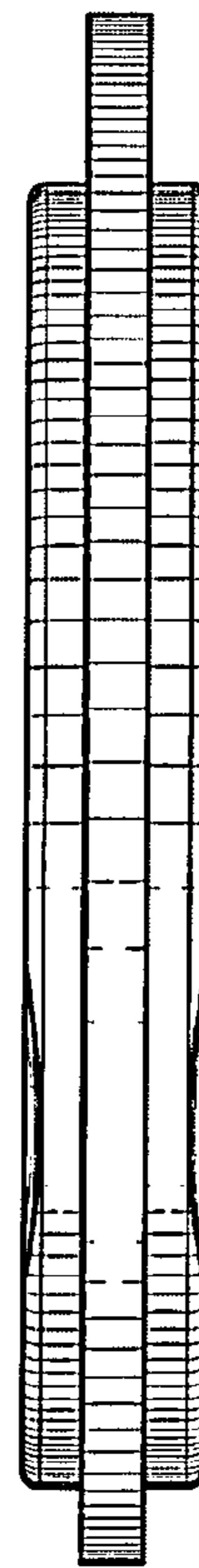

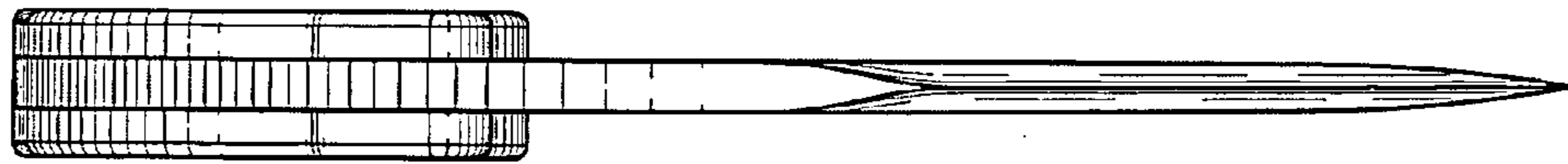

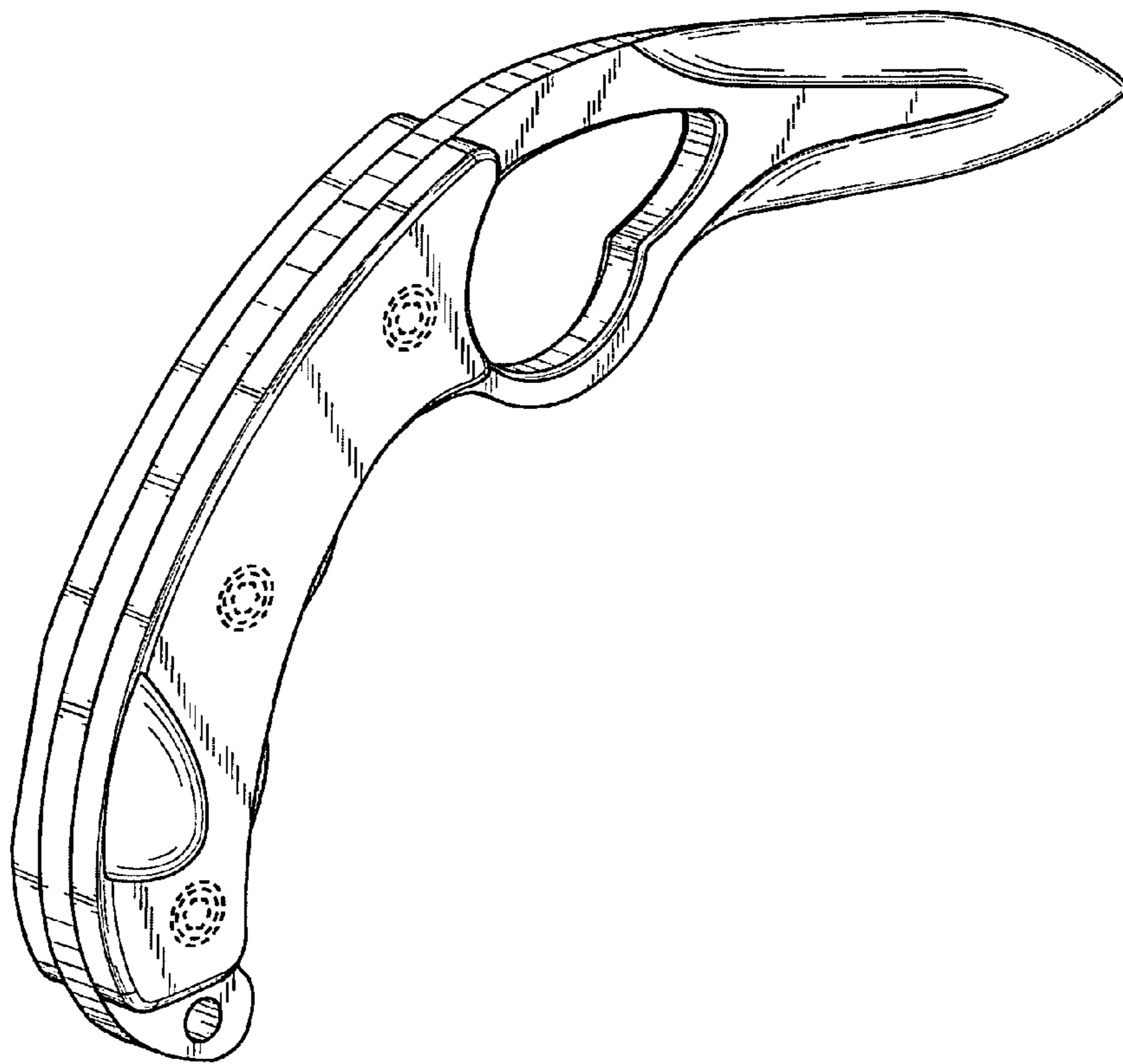

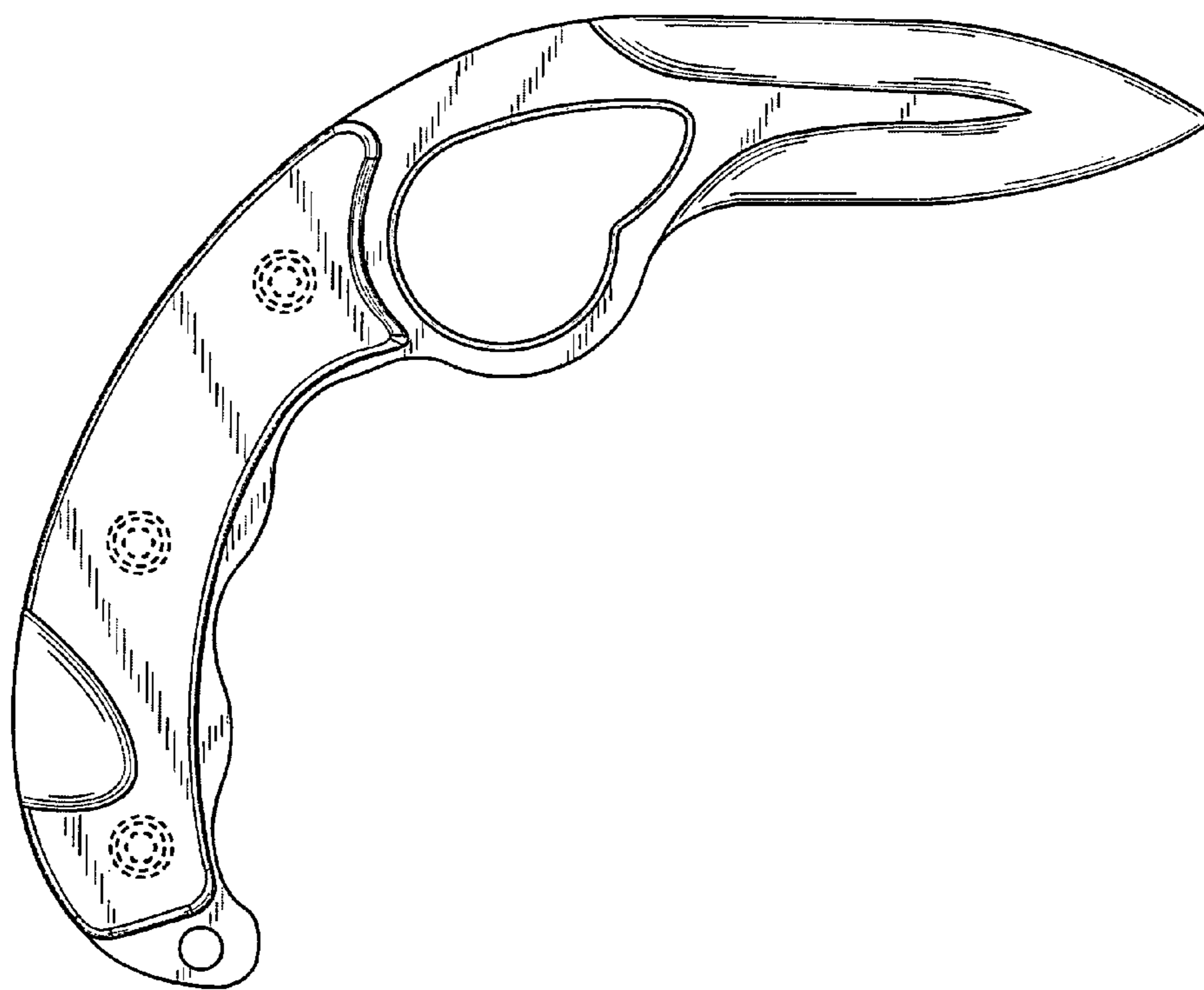

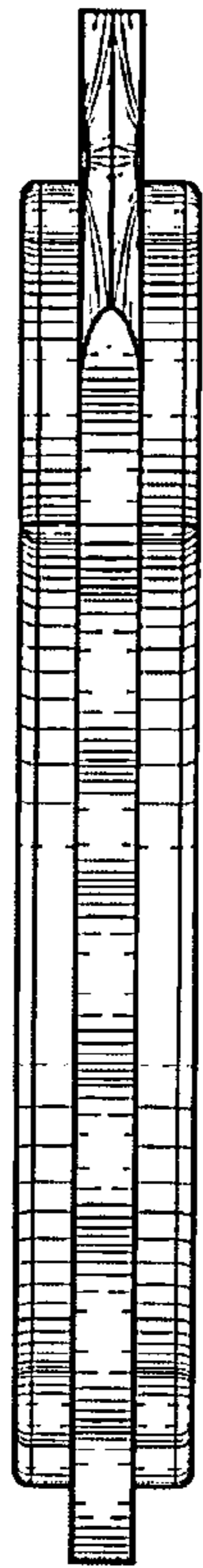

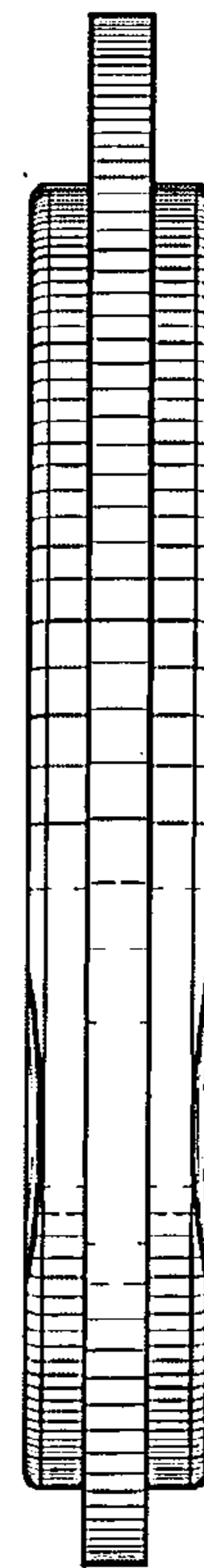

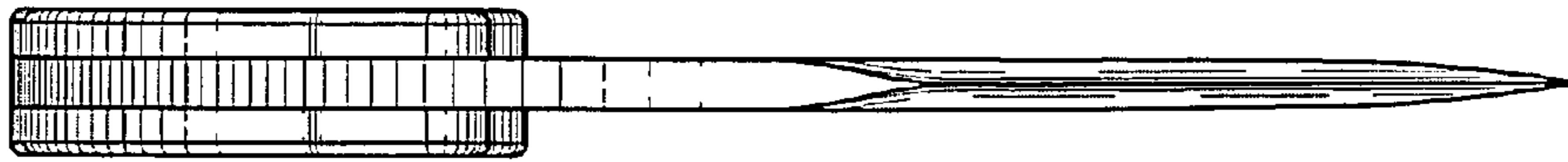
